SUBJECT: Monthly Military Pay Differential Report required by SF458, Section 21.

On May 31, 2003, the Governor signed Senate File 458. Section 21 of the bill is an appropriation of \$1,810,000 to the Department of Revenue and Finance (or its successor agency) for the primary purpose of paying a pay differential to state employees mobilized in support of various military actions. Section 21 of the bill also requires a monthly report to the fiscal committee of the legislative council on the use of the funds. This letter, with insert, constitutes the report for the month ended November 30, 2003.

During November 2003, the State Accounting Enterprise continued to receive substantiating document from mobilized employees and their spouses, and to calculate any military pay differential due the employee. As stated, current information on pay calculations and other status information is inserted.

Through November 30, there have been no requests for funds to take advantage of the family counseling provisions of the bill. From the inserted report, you will note that we continue to make few military differential payments. As stated in previous monthly reports, we believe the single biggest reason for few claims is that the population of mobilized state employees is mid-level or higher officers and NCOs, with 8-12 or more years of service. Because of the ranks and length of service, the military pay and allowances of mobilized employee exceed their state pay.

In late November, there were additional mobilization of both National Guard and Army reserve units throughout the state. We anticipate that these mobilizations will involve additional state employees and have sent reminder information to all departmental payroll clerks. We will continue to work with departments and individuals to assure that they are aware of potential benefits made available through this appropriation.
