Offenders on EMS

On November 30, 2009, 648 offenders were on some form of electronic monitoring (EMS), per the Iowa Corrections Offender Network (ICON). This represents a slight increase in the number on EMS about one year ago.

The Iowa Division of Criminal and Juvenile Justice Planning (CJJP) projects a large increase in offenders admitted to community supervision who will be required to be on EMS, due to the impact of offenders required to serve special sentences. In the short-term, CJJP estimates an increase of 300 offenders during FY 2010; the DOC projects 84% or about 250 will require electronic monitoring. For FY2011, CJJP estimates *another* 300 additional offenders under community supervision, and DOC projects 84% or about 250 will require electronic monitoring.

The chart on the next page shows the numbers of offenders on EMS by judicial district and EMS type.

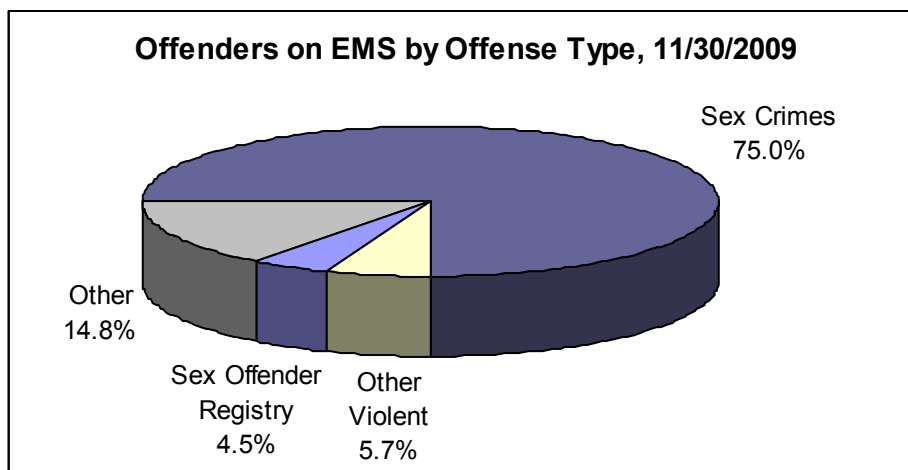
Previous state law mandated a minimum of five years of electronic monitoring for sex offenders whose crimes were against children. This law was changed in 2009 to permit discretion to the district departments of correctional services to base decisions on validated sex offender risk assessments and other factors. In response, the Iowa Department of Corrections developed new administrative rules to guide decisions on which sex offenders should be placed on electronic monitoring.

Offenders on EMS by Most Serious Offense

This section describes the most serious offense for offenders on EMS on November 30, 2009. As shown below, 75% of offenders on EMS were under supervision for a sex offense as their most serious offense. The rest were under supervision for other offenses, including other violent crimes and sex offender registry violations. The chart beginning on the next page lists the specific offenses. Please note some offenders have prior sex offenses that are no longer active, but are under supervision for other types of offenses.
