Iowa Homeland Security and Emergency Management Division FY 2011 Justice Systems Sub-Committee State Budget Briefing

The mission of the Iowa Homeland Security and Emergency Management Division (HSEMD) is to lead, coordinate and support homeland security and emergency management functions in order to establish sustainable communities and ensure economic opportunities for Iowa and its citizens.

HSEMD is guided by three goals that define the division's commitment to prevention, protection, response, and recovery.

Goal 1: Ensure that Iowa is prepared for disasters and terrorist attacks.

Goal 2: Minimize the impact, loss of life, loss of property and suffering caused by disasters and terrorist attacks.

Goal 3: Ensure that the statewide homeland security and emergency management team provides a worldclass service to the state of Iowa that meets the needs of its citizens.

This past year has not been without it challenges. The most daunting challenge the Division faced was the 10% across the board budget reduction. HSEMD address the 10% ATB in FY2010 by not filling positions that were budgeted for the year but became vacant through either turnover or retirement. These positions were Public Service Executive 3, Executive Officer 1, Program Planner 3, and an Administrative Assistant 2. Additional cost savings were obtained by shifting costs to federal grant dollars for three other positions within the Division. In total these actions allowed the Division to meet to 10% ATB (\$203,812).

Listed below is a summary of those funding sources that the Division manages. These include disaster recovery funds, federal grant funds, 911 surcharge funds, and the associated state general fund matches where appropriate. *In 2009, for each dollar of state money the Division received, we were able to obtain \$6.80 in federal funding.* For Public Assistance Programs this average \$7.50 for every state dollar and in the case of the Floods of 2008 can be as high as \$9 per state dollar. It is important that with most of the federal grant funds, their performance periods will stretch across multiple years. Thus the division will actively administer several specific years of grants from the same program simultaneously. With the exception of the disaster funds, these figures reflect those funds that are attributed to the prior year.
