#### PARKS AND RECREATION

- Three new state parks opened: Elinor Bedell at Spirit Lake in 1998, Banner Lakes at Summerset in 2004 and Honey Creek Resort in 2008.
- Interpretative programs and invasive species education and control have been expanded.

#### ANIMAL FEEDING OPERATION

 Regulations have grown in scope and complexity in pace with the growing number of operations required to have permits, manure management plans and facility inspections.

### **AIR QUALITY**

- · Greenhouse gases were declared a public health threat, 58% more facilities will need air permits.
- Tighter pollution standards mean a dozen areas could exceed standards.
- More than 2,000 facilities will become subject to new federal air toxic standards by 2012, doubling required inspections.

#### **EMERGENCY RESPONSE**

- Handles a majority of 870 spills per year and is the operations unit during emergencies.
- · Homeland security duties were added in 2001.

#### **FORESTRY**

• For every \$1 of General Fund money invested in forestry, \$5 was returned to lowa's economy through private timber sales, private sector jobs, seedling and timber sales, crop leases and leveraged resources with other organizations.

### CURRENT STATUS OF DNR PROGRAMS

#### STATE PARKS MOST AFFECTED BY CUTS

- Seasonal park staff has been cut from 300 to 32 and are being operated with 10% fewer full-time staff.
- Maintenance on \$260 million of infrastructure will be deferred, except for critical repairs.
- Portions of parks will remain closed, public programs will be reduced and mowing and upkeep will be minimal.

# FORESTRY CUTS IMPEDE SERVICE TO PRIVATE LAND OWNERS

- The State Forest Nursery at Montrose is closed; fewer trees are produced at the Ames nursery.
- Land conservation programs, landowner technical assistance, and community assistance are reduced.

#### AIR QUALITY EMISSIONS ASSESSMENT REDUCED

 Data analysis and review for smaller sources of emissions are reduced to a complaint-based review.

#### ANIMAL FEEDING OPERATIONS OVERSIGHT REDUCED

- Program staff has been cut in half, reducing oversight 23 to 11.5 and compliance assistance.
- With decreased technical assistance, history shows complaints and violations increase.

# GEOLOGICAL AND WATER ASSESSMENT WORK HALTED

- No longer collecting information for some of the state's long-term environmental and resource needs, such as identifying optimal locations for new municipal drinking water wells.
- · Cancelled proposed drilling contract work.

# WATER QUALITY MONITORING AND ANALYSIS WEAKENED

 Reduced data collection analysis and review increases risk and cost of bringing water supplies back into compliance.
