Clarinda Kitchen/Laundry Replacement Project

- \$ 5,242,619 Clarinda Kitchen Replacement (received in FY2022)
- \$ 4,000,000 Clarinda Kitchen Replacement (FY2023)
- \$ 750,000 Clarinda Kitchen Equipment (FY2023)
- \$ 4,900,000 DOC Infrastructure Projects (FY2023)
- \$ 14,892,619 Total Appropriations for this project
- \$ 598,321 Design/Pre-Construction Spent
- \$ 20,371,637 Bids in January 2023
- \$ 6,077,339 Current Deficit on project (pending being rebid)

Clarinda Kitchen/Laundry Replacement Project – Current Status

- DOM is currently drafting language for the prior appropriations to amend the reversion language to state that the funds will not revert until the Clarinda Kitchen/Laundry project is completed
- DAS is currently working to get updated bids for the project by end of February 2024
- Farmland Sales Funding will be used to supplement the current appropriations for the Clarinda Kitchen/Laundry Replacement Project to ensure it is completed

DOC Farmland Sales

- Sale of approximately 3,000 acres to support infrastructure needs of DOC
- Proceeds from the sale will be used for facility capital funding requirements
- Process is underway at DOC locations
 - NCCF (Rockwell City) sale finalized in January 2024 (162.53 acres sold for \$2,201,097 - \$13,543/acre) – still have to pay some ancillary costs
 - NCF (Newton) and ICIW (Mitchellville) working with DAS next in March/April 2024
 - ASP (Anamosa) and ISP (Fort Madison) Farms to be completed late summer/early fall 2024
 - Entire process to be completed by end of 2024
- First project to be funded is the remaining portion of the Clarinda Kitchen/Laundry Project

\$2,464,779 Camera System Upgrades of existing security cameras and supporting infrastructure

- \$ 200,000 IMCC Pharmacy Pill Counting/Sealing Machines
- \$ 100,000 IMCC (Coralville) Switch Replacements
- \$ 500,000 ICIW (Mitchellville) Switch Replacements
- \$ 200,000 Statewide ICIW/IMCC Server Replacement
- \$ 139,500 CBC Technology Upgrades

Major and Routine Maintenance Funding

Major Maintenance:

DAS currently has \$11,458,000 for 8 projects that are planned for the remainder of FY2024 for the Department of Corrections

Routine Maintenance:

DAS distributed \$849,166.47 in Routine Maintenance Funding to the Department of Corrections in FY2024. This funding was sent to the Institutions and Districts.
