lowa Lottery players took home two Hot Lotto® jackpots in 2011, but a third lowa jackpot won in the game remained unclaimed with just days to go before its expiration date.

Someone who bought a ticket at a Des Moines convenience store for the Hot Lotto drawing on Dec. 29, 2010, won the \$16.5 million jackpot that night, but no one has ever come to the lottery to claim the prize — and the winning ticket has never been checked on a lottery terminal in Iowa. The big prize is set to expire at 4 p.m. on Dec. 29, 2011, if it is not claimed by then.



Should that come to pass, the money from the jackpot will go back to the 15 lotteries that offer Hot Lotto in proportion to the percentage of sales that came from each state. Iowa law specifies that the money from unclaimed prizes goes into the lottery's prize pools for future games or special promotions, so it will be used to pay prizes to lowa players, just not those particular prizes that have expired.

And as the Hot Lotto jackpot's deadline approached, so did that for a \$77 million Powerball jackpot in Georgia. The prize-claim period for Powerball prizes in that state is 180 days, so the jackpot won there on June 29 expired Dec. 26 when no one claimed it by that time. The lowa Lottery also stood to receive back a percentage of that unclaimed prize money.



While final plans can't be put in place until after the prizeclaim periods expire, the lottery is discussing offering a spring promotion to give away the unclaimed jackpot money to lowa Lottery players with the theme of "everyone deserves a second chance." The total that would be given away in the promotion would be about \$1.9 million, the amount that the lottery would receive back from the unclaimed jackpots.

In comparison to those two instances, lowa's latest Hot Lotto jackpot winner claimed his prize within a few days of winning it. Wally Markham of Waterloo, who is retired after working for 36 years at the Deere & Co. plant there, won the \$7.54 million Hot Lotto jackpot in the drawing on Nov. 5. Markham, 65, said he planned to invest his winnings and planned to continue playing the lottery because he definitely intends to win again.

FY 2011 Results and FY 2012 Budget



A five-year comparison of lottery sales, expenses and proceeds is included in this report as **Attachment A**. Overall lottery proceeds were more than \$68 million in FY 2011 compared to \$57.9 million the previous year. The lottery's latest financial performance figures are included in this report as **Attachment B**, again showing positive proceeds to state causes.

Lottery proceeds through November, the latest month for which complete figures are available, were running about 15 percent ahead of FY 2011 figures for the same time period. That is especially positive news, given that FY 2011 was the best year in the lottery's history for lottery proceeds from its current products (lotto games,

instant-scratch games and pull-tab games).

We believe the lottery's continued sales success even during the current negative economic conditions comes from the current creative line-up of games and promotions, which produces variety and choices in the lottery entertainment options available; but also from the basic concept of a lottery itself. Lottery products remain today what they have always been: an affordable, local entertainment option. And, while consumers may be cutting back on larger entertainment expenditures, lottery products are something that is still available for just a dollar or two in local areas.

Lottery proceeds have increased at a higher rate than lottery sales for the year for a few different reasons. One of the biggest is the fluctuation in lottery prize claims, which is cyclical and may vary from year to year, but bears out to anticipated levels over time.

As always, we are closely tracking lottery results and providing regular updates about sales and proceeds through the state's I-3 accounting system.

During its Sept. 29 meeting, the lowa Lottery Board approved the lottery's FY 2013 budget. That budget took into account several upcoming factors, including the \$2 price point change for Powerball in January that is expected to increase sales revenues, and the lottery's plans to go out to bid for ticket-vending machines. The current machines have been in the field for a number of years and need to be replaced to maintain service. The budget took into account predictions of continued U.S. economic difficulties and conservatively projected a 2 percent growth in lottery proceeds from FY 2012 to FY 2013.

The lottery projects that its sales will total at least \$277.6 million in FY 2013 while lottery proceeds to state causes will total at least \$60.5 million.

As part of standard procedures, the lottery's budget figures have been entered into the state's I-3 accounting system and are available for review by all interested parties. In addition, detailed updates to the lottery's sales and budget figures are also regularly provided through the state's I-3 accounting system.

New Statewide Gaming System

After a 2½-year implementation project, the lowa Lottery's new statewide gaming system became fully functional on July 3, providing lottery retail locations and players with valuable advances in technology.

In general, the lottery systems that are used to sell and validate tickets are replaced about every 10 years. The lowa Lottery's lease for its previous system that had been in use since 2001 expired July 2. The lottery's contract with Georgia-based Scientific Games International for its new equipment is for seven years with three possible one-year extensions and is worth about \$50 million. It is the largest contract involved in the operation of the lottery.

Some highlights of the new gaming system include:

- Self-checkers all retail locations, allowing lottery players to check tickets on their own rather than giving them to the clerk to check.
- Lighted jackpot signs in many locations that communicate wirelessly with the lottery terminal to automatically update and display the latest jackpot amounts in Powerball® and Mega Millions®.
- Flat-screen monitors in many locations that display customer transaction details as well as lottery marketing messages.
- An updated version of the lottery's longtime VIP Club customer rewards program that players
 can join to participate in exclusive promotions and drawings. The update to the club allows the
 lottery to shift some of its prize payouts away from cash prizes and into merchandise with the



goal of broadening the lottery's player base by offering greater variety in the prizes that players can win. Nearly 40,000 lowa lottery players have joined the enhanced club since it was relaunched in May.

- A smart phone app that lottery players can use to check winning numbers and get the latest updates from the lottery.
- Bar-code scanning equipment being tested that may enable retail locations to scan customers'
 IDs for age-compliance purposes.

Updates To Powerball Game



As Powerball moves into its 20th year in 2012, the game is being redesigned to bring more value to its players. Beginning Jan. 15, the game's ticket price will be \$2. Powerball's starting jackpots will double to \$40 million and the jackpot will be easier to win. The overall odds of winning any prize also will be easier, and there will be more

chances to win a prize of at least \$1 million cash.

Since getting its start in April 1992 in 15 states with jackpots that started at a guaranteed \$2 million, Powerball has grown into one of the world's biggest and most recognizable lottery games. Today it's sold by 44 lotteries across the nation, with players buying more than \$3 billion annually in Powerball tickets. And the biggest jackpot in the game so far was a \$365 million prize split by eight co-workers at a Nebraska meat-packing plant in February 2006.

But with that success comes a demand for innovation to keep things fresh. U.S. lottery directors in June approved the upcoming changes to the game.

The \$2 Powerball game will debut Jan. 15. Players in the newly designed game will still choose their first five numbers from a pool of 59. But the group of numbers in the Powerball pool will shrink from 39 to 35, producing better overall odds of winning a prize in the game. Players today have a 1 in 35 overall chance of winning, which will improve to 1 in 31.8 in the revamped game. The Powerball jackpots will start at \$40 million, double the current starting jackpot of \$20 million.

By changing Powerball's ticket price to \$2, U.S. lotteries are following the same successful business model they've used for years with lottery scratch games by offering various tickets at different prices. The Mega Millions jackpot game and other in-state lotto, instant-scratch and pull-tab games will still be available for those players who prefer the \$1 price level of play.

The new Powerball game will still offer players nine ways to win prizes, with its second prize moving up to \$1 million in cash from the current \$200,000, and the lowest prize level (for those who match just the Powerball) being elevated to \$4 from \$3.

Internet Gambling

For the past two years, the lowa Lottery has been keeping you updated about the issue of Internet gaming. Discussions on the topic continue both in Washington, D.C., and here in lowa, with one of the most recent developments coming Dec. 23 from the U.S. Department of Justice. That day, the department sent a letter to the New York Lottery regarding the federal Wire Act. In its letter, the department said it had concluded that the Wire Act prohibits only the transmission of communications relating to bets or wagers on sporting events or contests.

New York has argued that the Wire Act is inapplicable to lotteries as it pertains to non-sports Internet wagering.

Several states around the country have begun to closely examine the issue of introducing lottery games on the Internet following release of the Department of Justice letter. The Iowa Lottery has not proposed any legislation or programs on the issue, but does continue to monitor it, as it is an important topic of discussion nationwide.

Additionally, legislation has been introduced both in Congress and in individual states to allow for the regulation of Internet gambling. In both the 2010 and 2011 sessions, legislation was introduced here in lowa to allow different forms of Internet gambling.

The lottery remains cognizant of its responsibility to provide proceeds for state causes and understands that for its products to remain relevant to today's consumers, it must keep abreast of advances in technology that change the way society communicates and conducts business. Current technology in many ways means that lotteries are using an offline business model in an online world. The lottery will continue to monitor and evaluate proper use of new technology to meet citizens' demands. We will provide updates to your committees and the Legislature as a whole about the changes that could be involved in lowa and the impact such issues could have on the state budget.

We will continue to offer ourselves as a business analyst to offer outside perspective, advice and revenue projections in these discussions.

Working Cooperatively & Promoting Iowa

Throughout this past summer and fall, the lowa Lottery continued its efforts to highlight important state causes by working on a summer travel promotion with the lowa Tourism Office and a fall tailgating promotion with the University of Iowa, Iowa State University and the University of Northern Iowa.

In July, the lottery released the nostalgia-themed "Monopoly™" scratch game and at the same time, began a promotion that allowed players to use their nonwinning Monopoly tickets as entries into a drawing for the chance to win lowa vacation packages.

The promotion was offered through the lottery's VIP Club. During the promotion drawing on Sept. 7, the following winners took these home getaway packages, which can be used into 2012:

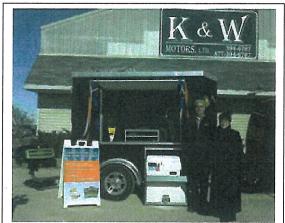

In August, the lottery released the sports-themed "Great State Tailgate" scratch game and began a promotion that allowed players to use nonwinning tickets in the game as entries into a drawing for a chance to win a towable tailgate trailer or one of five cash prizes of \$1,000. The lottery took the trailer to

a total of 11 homes games at the lowa, lowa State and UNI, encouraging people to get out and enjoy fall football in our state.

That promotion also was offered through the lottery's VIP Club. During the drawing on Dec. 8, five players won prizes of \$1,000 cash while Jeff Weigel, a car salesman from New Hampton, was selected as the grand-prize winner of the towable tailgate trailer, which came equipped with:

- 42-inch LCD HDTV with DirecTV® receiver and HD auto satellite antenna
- SONY® theater system with iPOD® Direct Connect
- Hitch-mounted tailgating gas grill and 54-qt. cooler on full slide system
- 1000W portable generator
- 30 AMP electrical panel box
- \$2,000 cash for customizing the trailer, travel, and spending money.

Hot Lotto Jackpot Timeline

Dec. 23, 2010: A \$10 Hot Lotto ticket is purchased at a Des Moines convenience store with two plays for five consecutive drawings.

Dec. 29, 2010: One of the plays on that ticket matches all six numbers selected in that night's Hot Lotto drawing to win the multi-million-dollar jackpot.

Throughout 2011: The lottery issues reminders that the winning ticket is still unclaimed and the deadline to claim the prize is 4 p.m. Dec. 29, 2011.

Dec. 29, 2011: The winning ticket is presented at lottery headquarters in Des Moines with less than two hours to go until the prize would have expired. No member of Hexam Investments Trust, the entity claiming the prize, is present. The lawyers who presented the ticket said they didn't have details sought by lottery about who purchased ticket, where it had been for the past year, and who the prize winners were. The lottery continues to seek information.

Jan. 17, 2012: Crawford Shaw, the trustee who had signed the winning ticket on behalf of the trust, meets with lottery officials. He states that he misspelled the name of the trust and that it actually is Hexham Investments Trust. While some documents relating to the trust are presented, they do not provide the details sought by the lottery. Shaw says he is not the prize winner and did not purchase the winning ticket. He also states he does not know the information sought by the lottery.

Jan. 23, 2012: To try to bring closure to a situation that had lingered for 13 months, the Iowa Lottery sets a deadline of 3 p.m. Jan. 27, 2012, for the requested information to be provided or the jackpot claim would be denied.

Jan. 25, 2012: The trust makes an offer to the lottery, stating that if the lottery will pay the prize, the entire prize winnings will be given to charity. However, the necessary information sought by the lottery is still not provided.

Jan. 26, 2012: The lottery denies that request and continues to seek the information it has requested. At 6:05 p.m., the lottery receives confirmation that the jackpot claim has been withdrawn. At 7 p.m., the lottery holds a news conference to share that development. Immediately following, the Iowa Attorney General's Office and Iowa Division of Criminal Investigation issue a joint statement announcing that they have begun an investigation into the matter.
