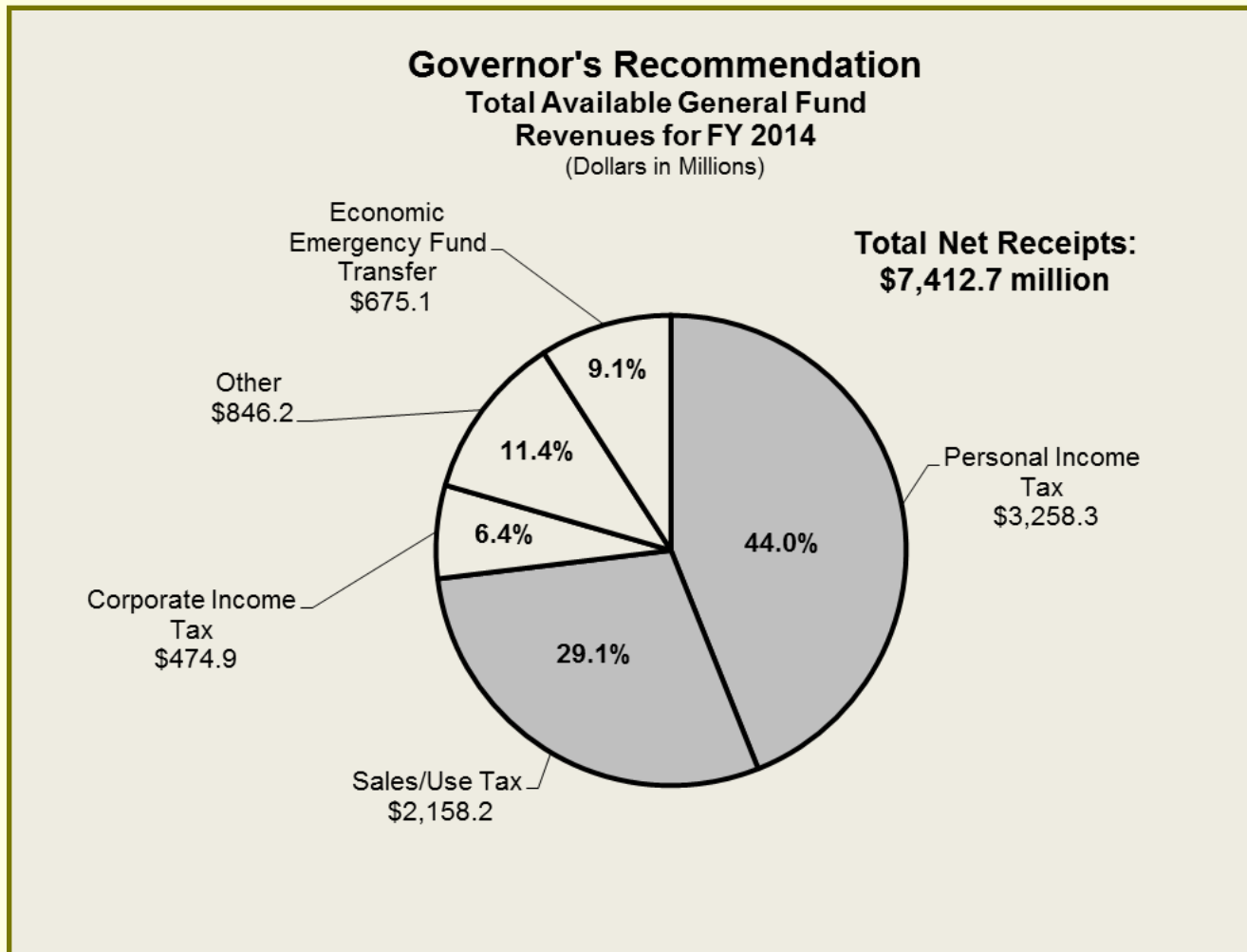

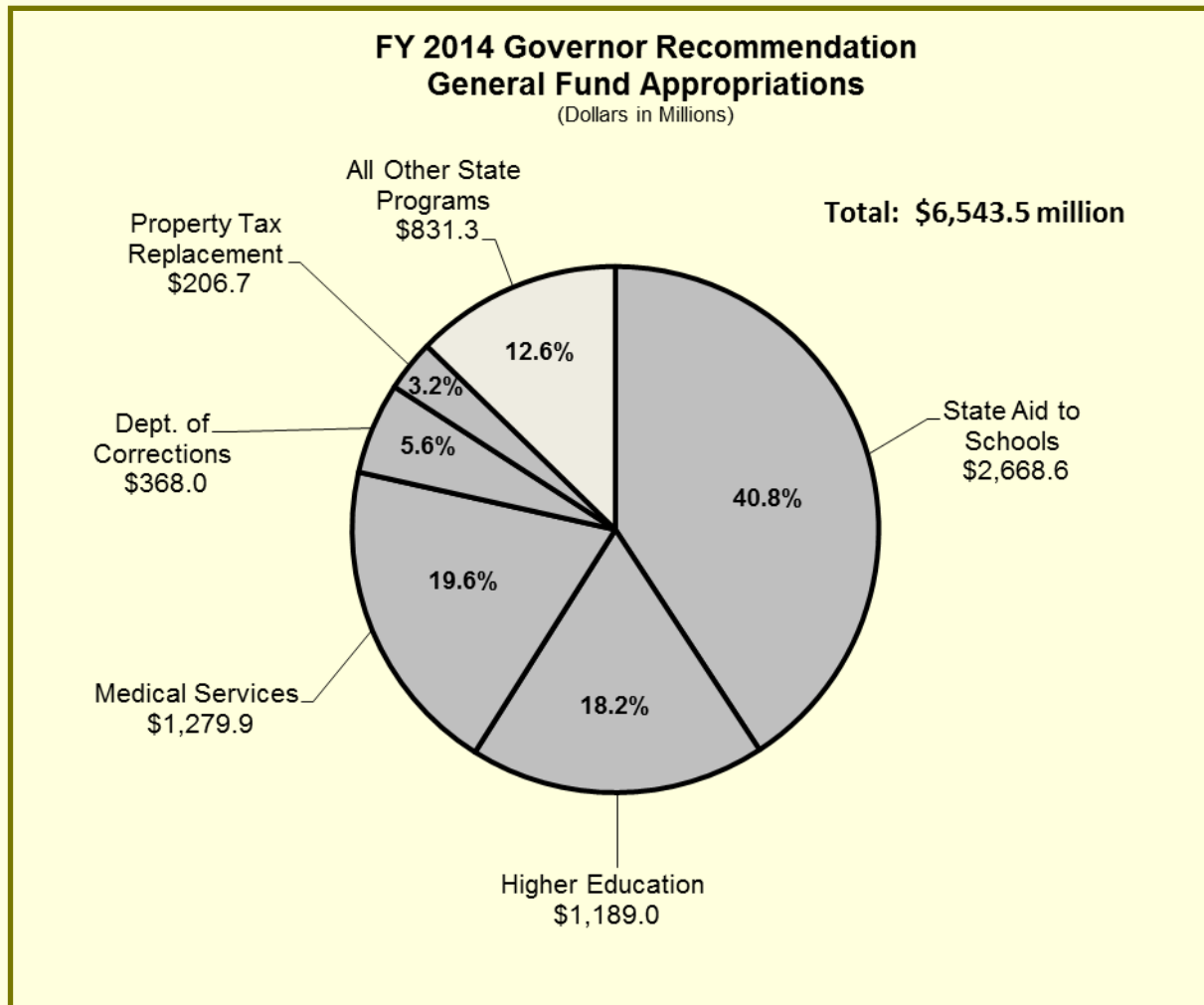

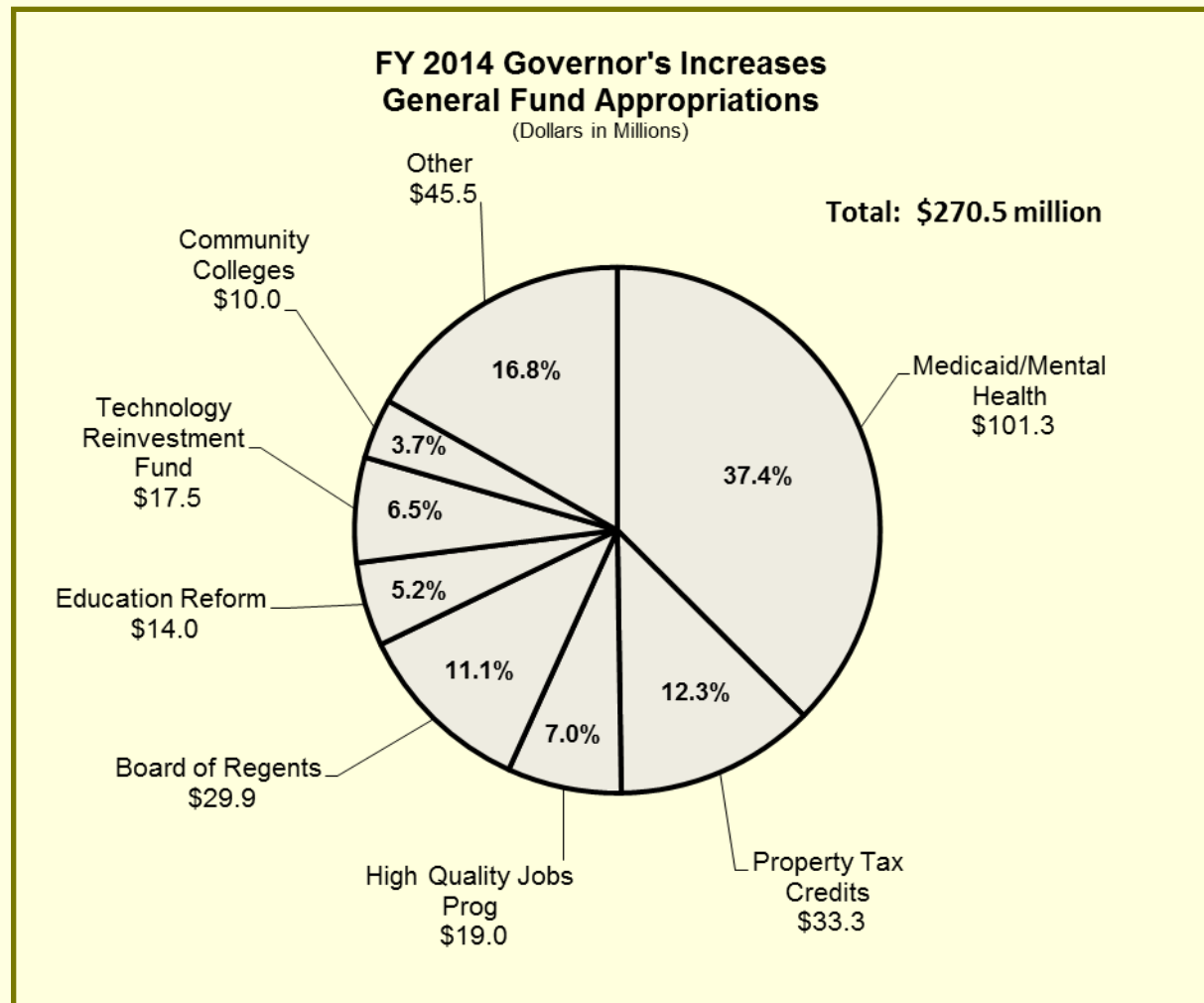

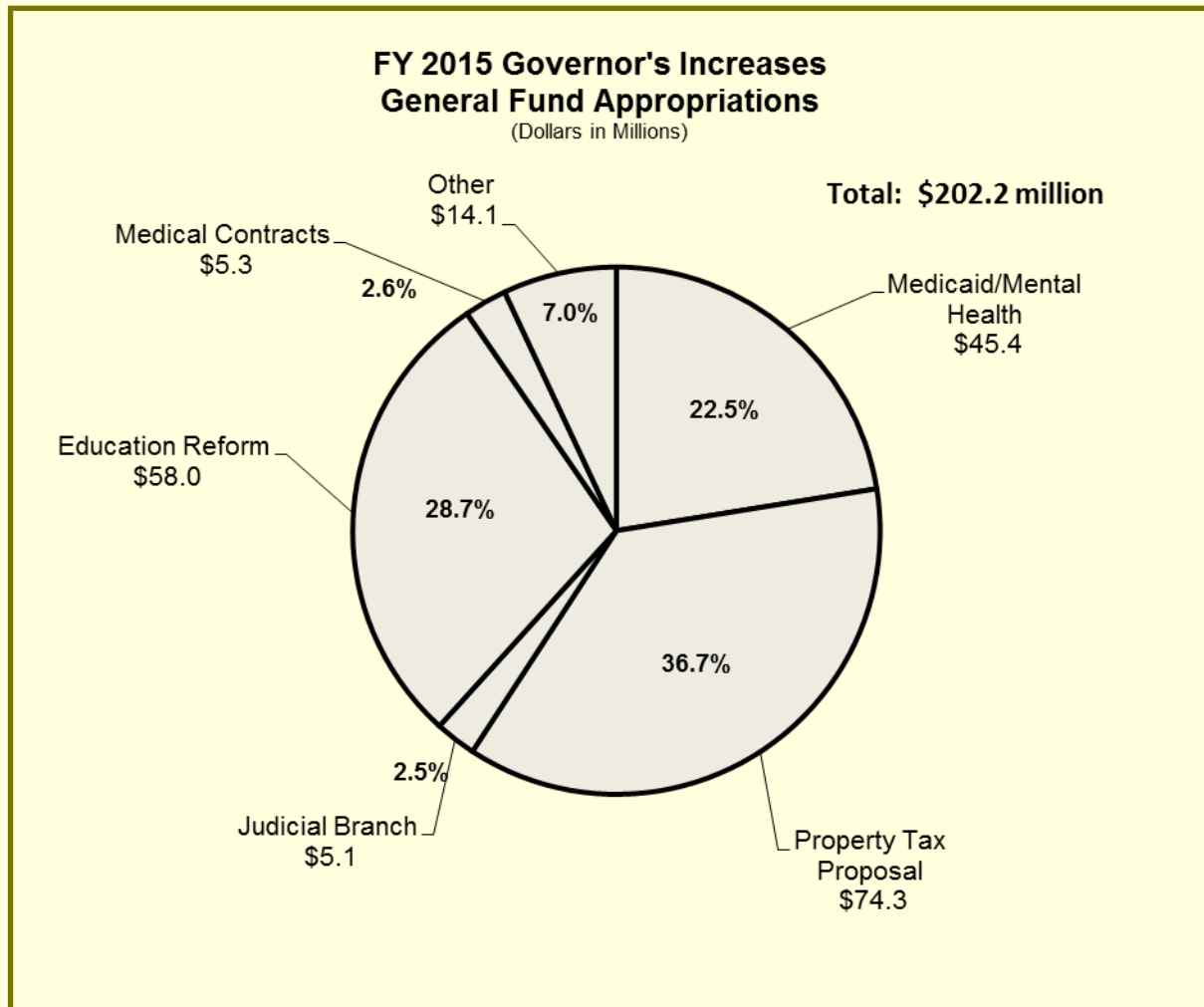
FY 2014 Appropriation Increases

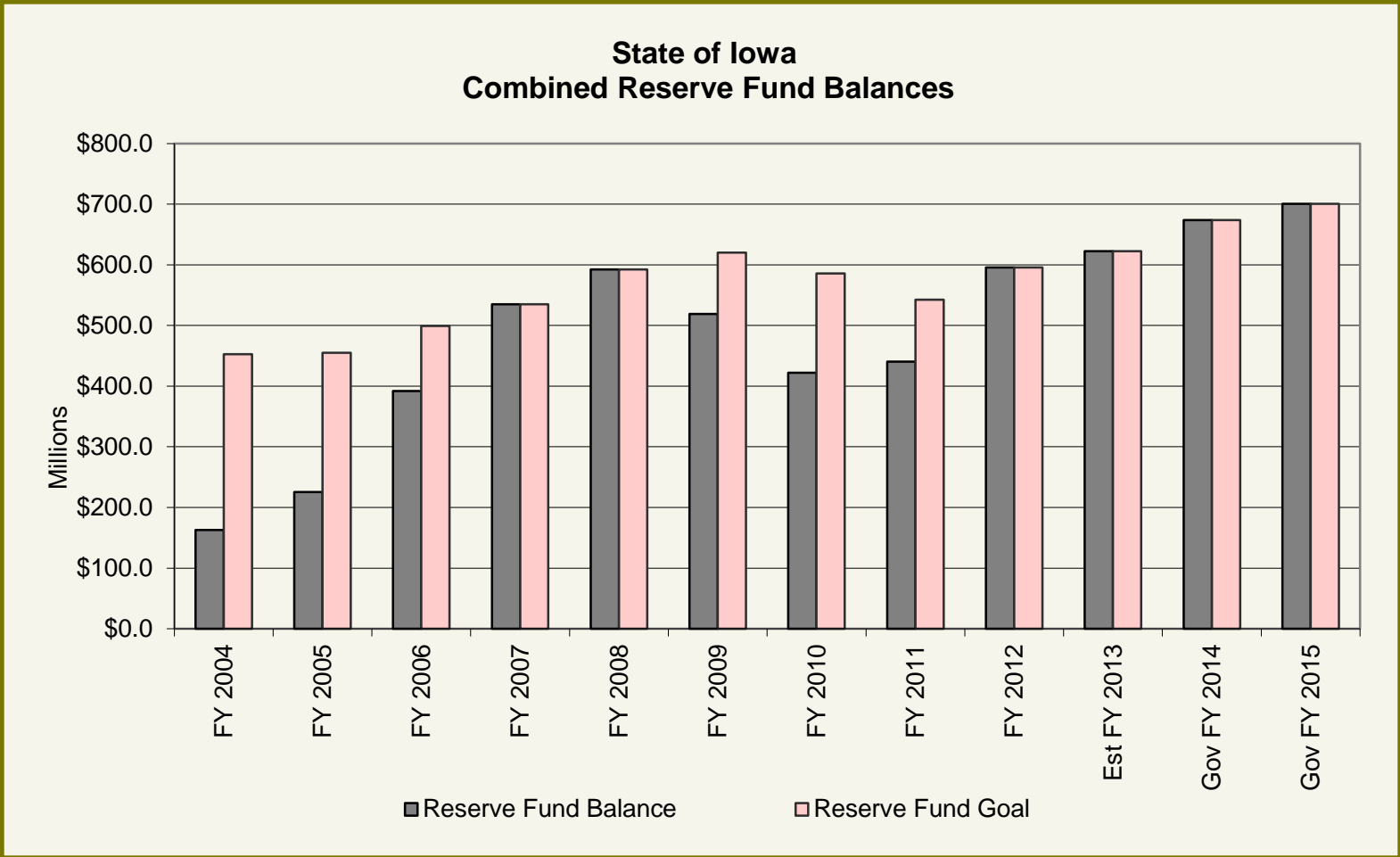

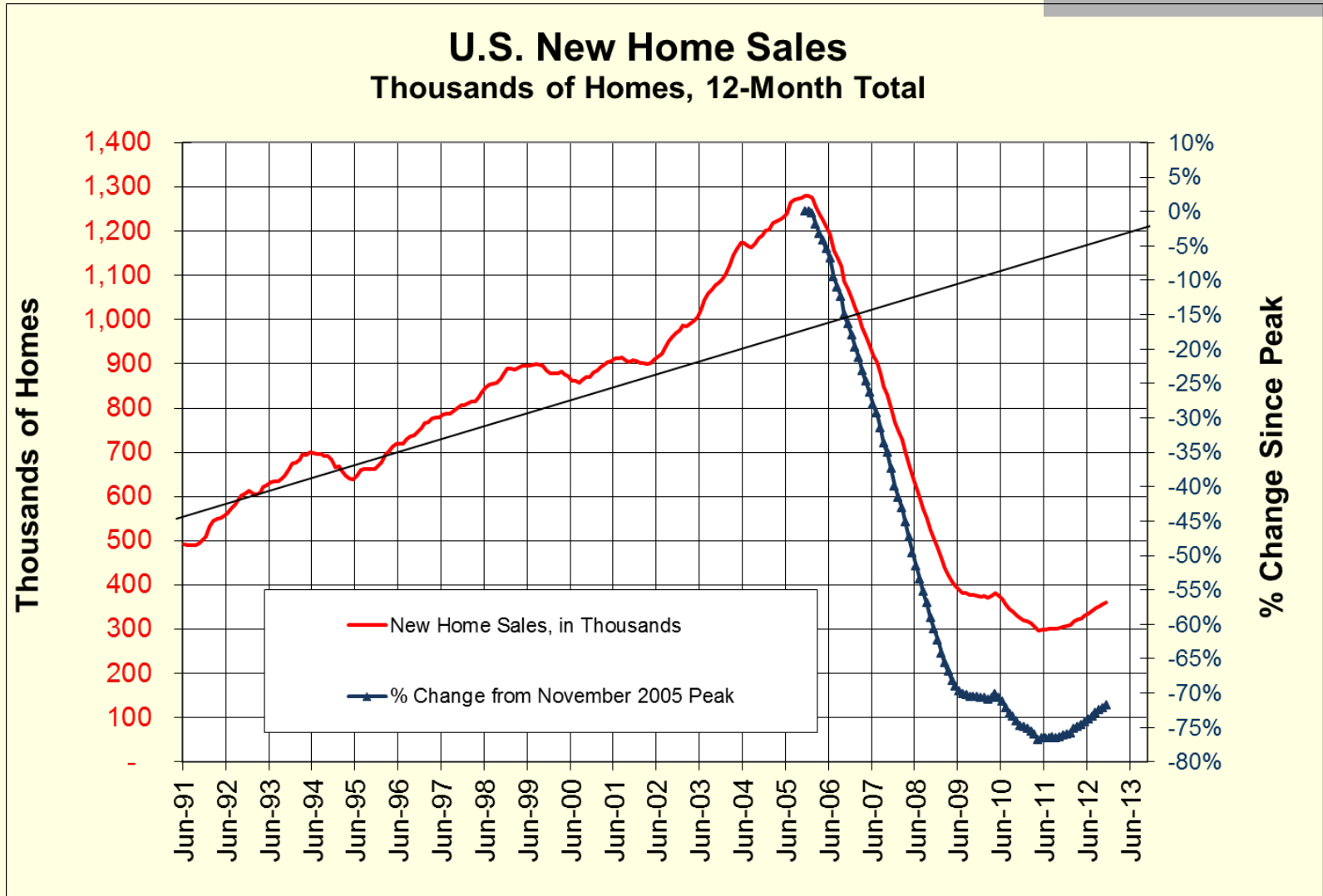
State & Local Sources of Tax Revenue and Tax Revenue Per Job

Iowa State and Local Taxes Collected Per Job

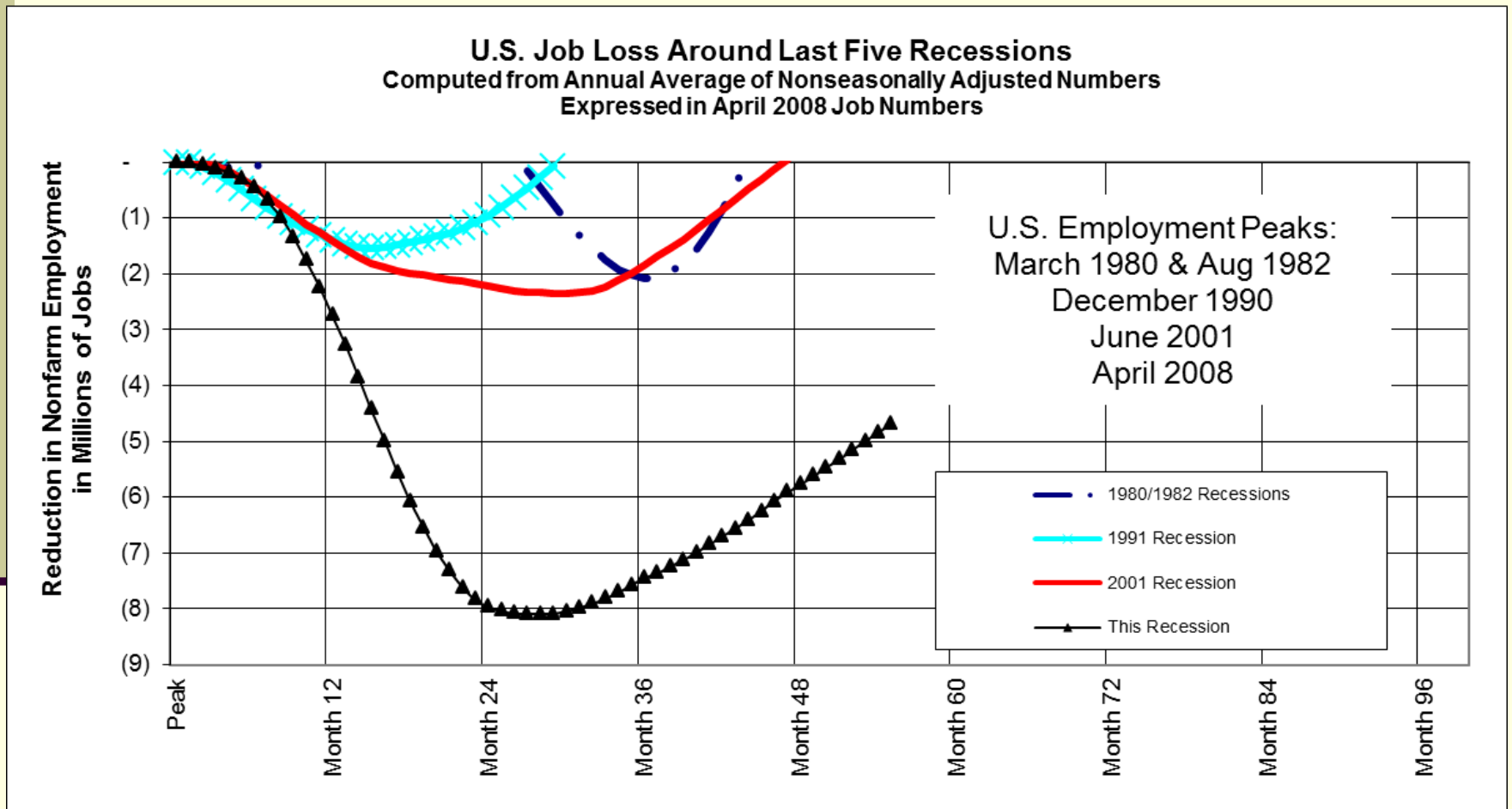

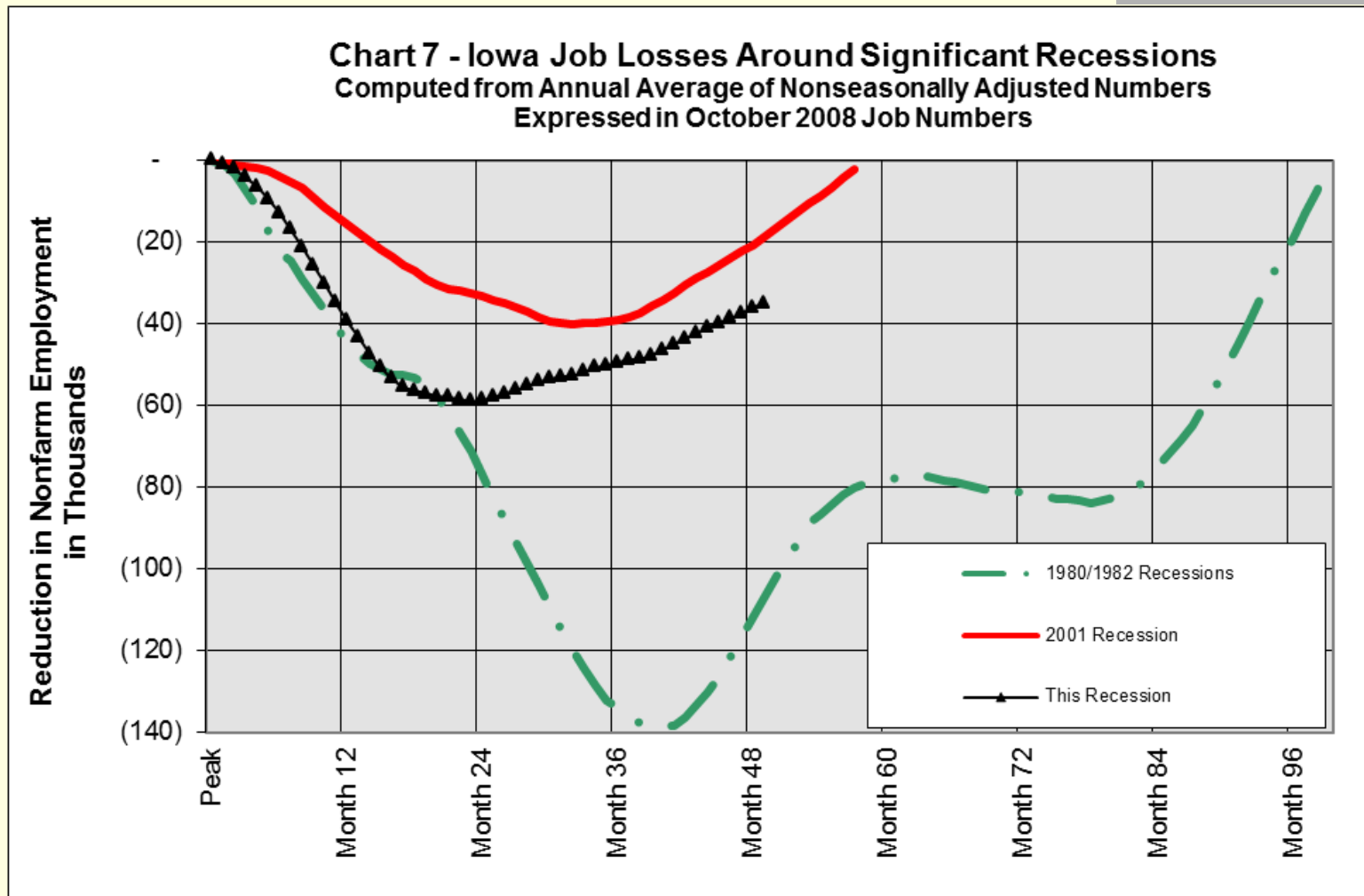
U.S. new home sales are 70% below their 2005 peak, and the direction turned down after the tax incentives ended. The recent trend is positive.



U.S. employment growth has also been growing for about two years, but the climb back to the pre-recession peak is much more problematic.



Current employment numbers show that Iowa employment has been growing for just over two years and to reach the pre-recession peak in two more years will take job growth acceleration.



Current revenue situation and some economic indicators: The two main drivers of General Fund revenue, withholding deposits and sales/use tax, are contributing to a very positive revenue situation and combined with significant corporate revenue increase, tax receipts are up considerably over the past six months.

Increase Shown Over the Past Six Months Compared to the Same Months Last Year

Personal Income Tax Withholding	6.8%
Sales/Use Tax, Net of Refunds	3.9%

However, widely–available state economic indicators of employment and income are mildly positive at best, indicating that the economy is pretty weak.

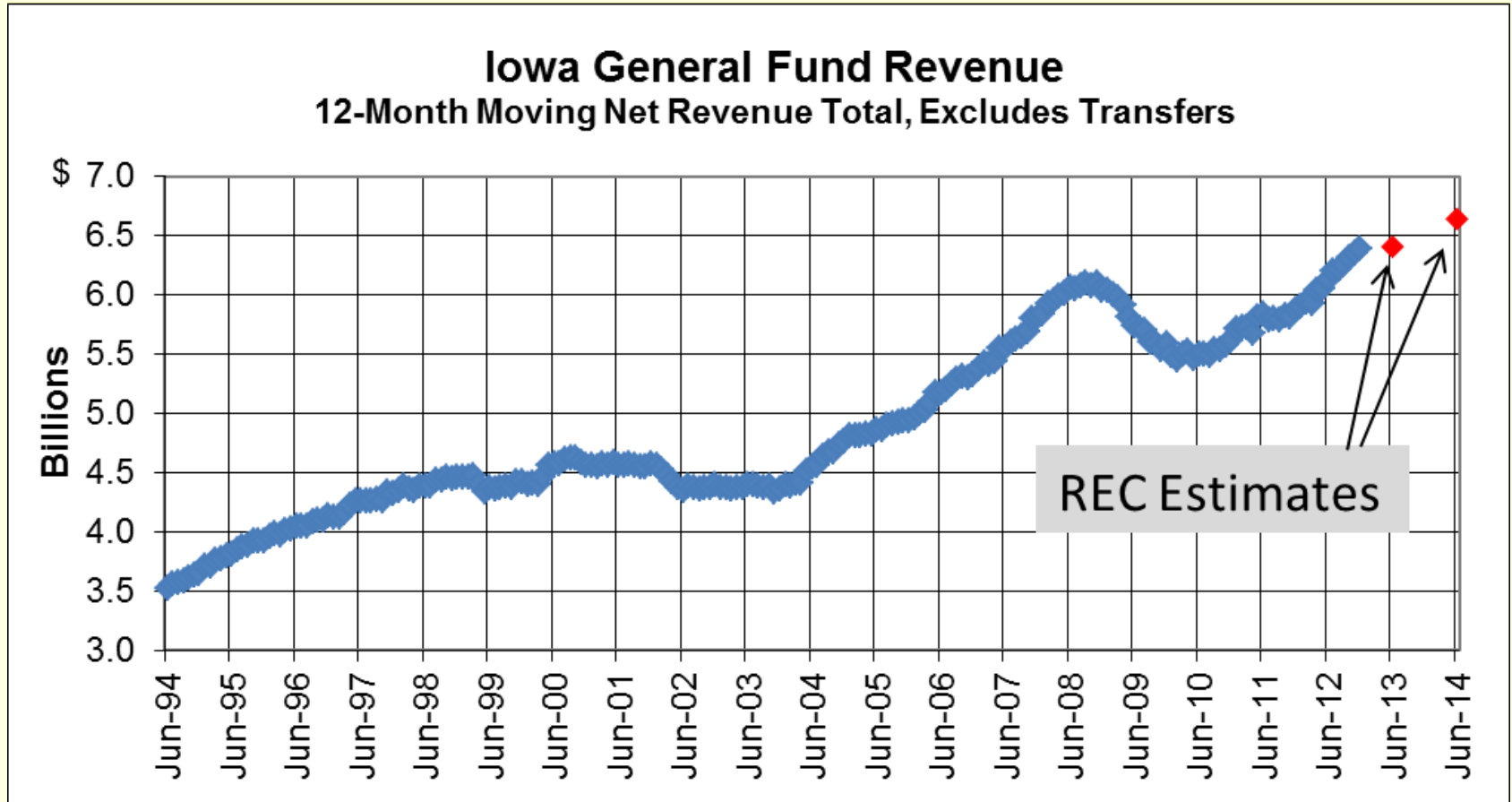
