


Iowa Governor's Office of Drug Control Policy (ODCP) 2013 Legislative Priorities At-A-Glance

2013 ODCP Legislative Proposals

- 1. Reduce Prescription Drug Diversion and Abuse. Amend §124.403 Controlled Substances—
 Prohibited Acts—Distribution, Use, Possession—Penalties to increase the penalty for diversion from Serious Misdemeanor to Class 'C' Felony, consistent with current "doctor shopping" penalties in §155A.23. Amend §124.552 Controlled Substances—Drug Prescribing and Dispensing—Information Program to help with timely identification of suspected "doctor shoppers" and reduce Medicaid fraud. Submitted online and delivered for filing
- 2. Reduce Marijuana Distribution and Use. Amend §124.204 and §124.206 Controlled Substances— Standards and Schedules to reinforce and clarify that marijuana is a banned Schedule I Controlled Substance in Iowa, deleting potentially ambiguous language that discusses exceptions for medical purposes. SSB 1045 and HSB 52 "An act relating to the controlled substance of marijuana, providing a penalty, and including an effective date provision."
- 3. Reduce Synthetic Drug Distribution and Use. Amend §124.201, §124.204 and §124.401 Controlled Substances—Standards and Schedules and Offenses and Penalties to strengthen lowa's synthetic drug controls by outlawing more new compounds, expanding the Pharmacy Board's temporary emergency scheduling authority and increasing delivery, intent to deliver and manufacturing penalties to be commensurate with marijuana (class 'D' felony vs. current aggravated misdemeanor). Submitted online
- 4. Deter Illegal Drug Distribution, Manufacturing and Use. Amend §453B.1 and §453B.7 Excise Tax on Unlawful Dealing in Certain Substances to update and strengthen lowa's Drug Tax Stamp Law by increasing taxes and fines for violations, and adding language to expressly apply the law to packages of synthetic drug products being sold in some lowa retail outlets. SSB 1029 and HSB 55 "An act relating to the excise tax on unlawful dealing in certain substances by adding new taxable substances and tax rates, modifying the taxation and rates of currently taxable substances, and making penalties applicable."
- 5. **Update Advisory Councils**. Amend §124.212C and §80E.2 *Controlled Substances—Standards and Schedules and Drug Enforcement and Abuse Prevention* to disband the non-functioning Pseudoephedrine Advisory Council and streamline meeting requirements of the Iowa Drug Policy Advisory Council. SSB 1036 "An act relating to the governor's office of drug control policy and certain advisory councils."


Meth Lab Incident Responses 2012









Iowa Drug-Related Prison Admissions (CJJP)






Presence of an Illegal Drug in Iowa Child's Body Confirmed Child Abuse (DHS-CYs)




Iowa Drug Overdose Deaths (DPH)




Iowa Rx Non-Heroin Opiates & Synthetics Treatment Admissions (TEDS)




Hydrocodone and Oxycodone ID Calls from Iowans (SPCC-CYs)




Iowa "Doctor Shopping" Patients with 5 or More Prescribers or Pharmacies (DPH, PMP)



Doses of Controlled Substances Prescribed To Iowans in CY 2011 (BOP)





Iowa Poison Center Exposure Calls For K2 or Bath Salts (SPCC)




Primary Substance of Abuse for Iowa Juvenile Treatment Clients (DPH 2012)
