We appreciated the opportunity to appear before your subcommittee and discuss the Department of Justice. As I mentioned, we are always available for questions and would be more than happy to have your committee members visit our offices to learn more about what we do.

In response to Beth Lenstra's email regarding follow-up questions, I am submitting the following information:

- 1. <u>Legal Services Cornoration of Iowa (LSCI)</u>. I spoke with Dennis Groenenboom of LSCI today and he indicated that he would provide the requested information as soon as possible, hopefully by the end of this week.
- 2. <u>Toys</u> 'R' Us Settlement. I am attaching a summary of the distribution of funds received in the Toys 'R' Us settlement. As I discussed at the meeting, the settlement was intended to provide restitution to the victims of the alleged anti-competitive activity. The court approved the distribution of toys and money for toys and books as a way to provide such restitution. While the settlement dollars belonged to the victims and were distributed as directed by the court, \$12,587 was received by the State of Iowa for attorneys fees and this money was deposited in the antitrust enforcement fund.
- 3. <u>Forfeitures.</u> I am attaching a summary by county of the forfeiture funds (cash and vehicles) received for FY99 and FYOO. We can provide further breakdown by agency if needed. In answer to Beth's question, there are no federal restrictions on the expenditure of moneys in the forfeiture fund maintained by the Iowa Department of Justice.

Summary of Distribution of Toys 'R" Us Funds

January 23, 2001

The Iowa settlement in the "Toys 'R' Us" litigations includes cash and toys with a value totaling approximately \$450,000. The majority of the proceeds of this settlement are in the form of toys that are being distributed over three holiday seasons through the U.S. Marine Corps "Toys for Tots" program. The cash portion, \$141,482, was distributed through a Court approved grant process to agencies and organizations that serve at-risk youth to aid them in their delivery of services. (Attorneys fees in the amount of \$12,587 were awarded- to the state and deposited in the anti-trust enforcement fund.)

In August of 2000, the Iowa Attorney General's Office sent out 60 invitations to apply for the cash portion of the settlement and subsequently received 63 applications with dollar requests totaling \$259,619. The applications received are summarized below and then listed individually in a chart.

In general the grant applications were of a very high quality. In order to spread the available funds as far as possible, and because of the generally good quality of the requests, the maximum award was limited to \$4500. We had estimated it might be \$5,000.

Because the bulk of the total funds from the settlement are already being made available to needy youth in the general population through Toys For Tots, the stated purpose of this grant process was to provide therapeutic or programmatic benefit to juvenile justice or child welfare system youth or youth highly at risk to enter those systems. Since the number of requests exceeded the funding available, this criteria was used as the basis for declining some requests and reducing the grant amount for others.

Reductions were also made in some grant awards because of the large number and size of requests made from the same area. Evidence of collaboration was included as a criteria in the application. Multiple non-coordinated grants tend to demonstrate less collaboration. A goal of the process was to distribute the funds fairly and evenly around the state as much as that was possible.

Some grants were ranked more highly simply because they had a more effective plan or creative use for the material, for instance serving larger numbers of youth with the same materials. These grant applications tended to receive an amount closer to full funding while those who were less creative, therapeutic or programmatic tended to have greater dollar reductions from their requested amount.
