Sec. 7C.12	Governor’s designee to administer Chapter 7C – private activity bond allocation relating to reallocation of the State ceiling among governmental units is required to issue a report that includes amount, date, politician subdivision, and reason for the reallocation.	Quarterly when reallocation takes place.
Sec. 8.7	Executive Branch departments are to report to the Ethics and Campaign Disclosure Board and the Government Oversight Committee regarding gifts and bequests received by a department or accepted by the Governor. The Ethics and Campaign Disclosure Board is required to submit a summary of the information to the Government Oversight Committee.	January 31 of each year from the Ethics and Campaign Disclosure Board
Sec. 8.9	The Department of Management is required to submit reports regarding the Grants Enterprise Management System (GEMS) listing all grants and summarizing departmental compliance with the requirements of the grant information.	January 31 of each year regarding the list of all grants; a semi-annual by July 1 and January 1 for the compliance information
Sec. 29C.20A	The Homeland Security and Emergency Management Division is required to submit a report regarding the activities of the Disaster Aid Individual Assistance Grant Fund.	January 1 of each year
Sec. 34A.7A	The Homeland Security and Emergency Management Division is required to submit a report advising on the status of E911 implementation and operations, including both wire-line and wireless services, distribution of surcharge receipts, and an accounting of revenues and expenses.	Annual by January 15
Sec. 99G.7	The Chief Executive Officer of the Lottery Authority is required to submit a report regarding updates on operations.	Semiannually
Sec. 99G.40	The Lottery Authority is required to submit a proposed operating budget and the estimated net proceeds to be deposited in the General Fund for the next succeeding fiscal year.	Annual by October 1
Sec. 135.150	The Department of Public Health is required to submit a report regarding the Gambling Treatment Fund, including revenues and expenses related to the Fund and the grants awarded for operation of the Gambling Treatment Program.	Semiannually

Section 175.8	The Director of the Agricultural Development Authority is required to submit a report regarding operations of the Authority.	Semiannually
Sec. 216A.133A	Requires the Public Safety Advisory Board of the Criminal and Juvenile Justice Planning Council in the Department of Human Rights to issue a report delineating funding sources.	December 1 of each year
Sec. 307.46	Requires the Department of Transportation to delineate expenditures when funds remain in the operational appropriation and are unexpended or unencumbered.	June 30 of each year when funds remain
Sec. 523A.801 and 523I.201	Requires the Insurance Division to report on the administration of the Iowa Cemetery Act and any recommendations to prevent abuses or evasions of the law. This includes regulation of preneed funeral and cemetery sellers and perpetual care cemeteries.	Annual by October 1
