**RESTATED ARTICLES OF INCORPORATION  
OF  
IOWA JOINT UTILITY MANAGEMENT PROGRAM, INC.**

Pursuant to the Revised Iowa Nonprofit Corporation Act, Chapter 504, Code of Iowa, the corporation adopts the following restated Articles of Incorporation.

**ARTICLE I  
NAME**

The name of the corporation is Iowa Joint Utility Management Program, Inc.

**ARTICLE II  
DURATION**

The corporation shall have perpetual duration.

**ARTICLE III  
PURPOSES**

The purpose of the corporation shall be to provide energy and energy-related services to school districts, other public agencies and non-profit organizations.

**ARTICLE IV  
REGISTERED OFFICE AND AGENT**

The address of the corporation's registered office in the State of Iowa is 6000 Grand Avenue, Des Moines, Iowa 50312-1417, and the name of its registered agent at such address is Ronald M. Rice.

**ARTICLE V  
DIRECTORS**

The number of directors constituting the corporation's board of directors shall be no fewer than five (5) and shall not exceed nine (9).

The directors shall be appointed and shall serve for terms in the manner provided by the corporation's bylaws.

**ARTICLE VI  
BYLAWS**

The board of directors shall have the power to adopt, alter, amend or repeal bylaws for the corporation which shall be consistent with these Articles of Incorporation.
