We have received 10 CAT applications. \$7.2 million is remaining for award this fiscal year. Requested amounts from Atlantic (\$700,000) Boone (\$2.67 Million) Cedar Rapids (\$500,000) Indianola (\$20,000) Monticello (\$489,370.07) Mount Pleasant (\$150,000) Pella (\$931,000) Red Oak (\$500,000) and Sioux Center (\$3.3 million) total **\$9,260,370**. An application from Greenfield (\$60,193.12) did not pass out of staff review because they were requesting more than 50% of the total project cost from CAT funding, which is not allowed under the legislation governing the program. The CAT program will continue for three more years with funding of \$12.5 million per year.

We have received 5 Vision Iowa applications. Requested amounts from Council Bluffs (\$36,616,294) Dubuque (\$58,031,004) Sioux City (\$33 million) Polk County (\$75 million) and Marshalltown (\$16,578,456) total **\$219,225,754**. (\$4 million of Council Bluffs' request is for a loan.) The funding stream for Vision Iowa is \$15 Million per year for 20 years. The Vision Iowa board has authority to issue bonds to be repaid by this future revenue stream. Bonding amount may be approximately \$180 million depending on several factors.
