Bio: George J. Weiner, M.D. is the Director of the Holden Comprehensive Cancer Center at the University of Iowa. He is also the C.E. Block Chair of Cancer Research, Professor of Internal Medicine, and a faculty member in the Interdisciplinary Graduate Program in Immunology at the University of Iowa.

Dr. Weiner obtained his undergraduate education from Johns Hopkins University, his medical degree at The Ohio State University, his Internal Medicine Training at the Medical College of Ohio and his Oncology and Hematology training at The University of Michigan where he also trained in tumor immunology. He has been a faculty member at the University of Iowa since 1989. Dr. Weiner is board certified in Internal Medicine, Hematology and Medical Oncology. In 2000 he led the Holden Comprehensive Cancer Center to recognition as a National Cancer Institute-designated Comprehensive Cancer Center, one of 39 such centers in the United States.

Dr. Weiner remains an active clinician and cancer researcher. His research focuses on use of the immune system to treat cancer. He is the Director of the University of Iowa / Mayo Clinic Specialized Program of Research Excellence (SPORE) in lymphoma, one of three lymphoma SPORE grants funded by the National Cancer Institute. The SPORE is designed to use scientific advances from the laboratory to develop new approaches to the prevention and treatment of lymphoma. He is also the principal investigator of additional research grants from the National Cancer Institute and the Leukemia and Lymphoma Society in the field of immunotherapy of cancer.

Dr. Weiner is a member of the Board of Directors of the Association of American Cancer Institutes, a member of the governmental affairs committee of the American Society of Hematology, and a member of the National Cancer Institute committee that determines which cancer centers will be formally recognized and funded by the National Cancer Institute.

Dr. Weiner serves as Chair of the State of Iowa Comprehensive Cancer Control Consortium. He is a strong advocate for enhancing the interactions between academic cancer research centers and community cancer control advocates, and using their combined strengths to decrease the suffering and death from cancer.
