## ADJUDICATORY PROCEEDINGS

Entered into contract to develop system with Tybera Development Group, Inc. in October 2013.

### *Why Tybera?*

- Company that developed Judicial Branch's electronic filing system
- Fully vetted by the Judicial Branch
- Same look & feel as Judicial Branch's system
- Attorneys already familiar with it
- Purchase the license

### *When will it be ready?*

- "System Up" date: June 30, 2014
- Training at PERB's biennial conference on September 22-23, 2014
- Target mandatory usage date: January 1, 2015 (depends on rulemaking process)

### *How much is this going to cost?*

- Tybera
  - One time charge of \$45,000 (includes \$15,000 license)
    - Paid out of FY14 budget, mostly Training and Technology Fund
  - Annual maintenance costs of \$3,000
  - Annual monitoring costs of \$2,500 (can be terminated at any time)
- ITE
  - One time charge of \$2,291.92
    - Paid out of FY14 budget
  - Monthly cost of \$595.08, or annually, \$7,140.96
