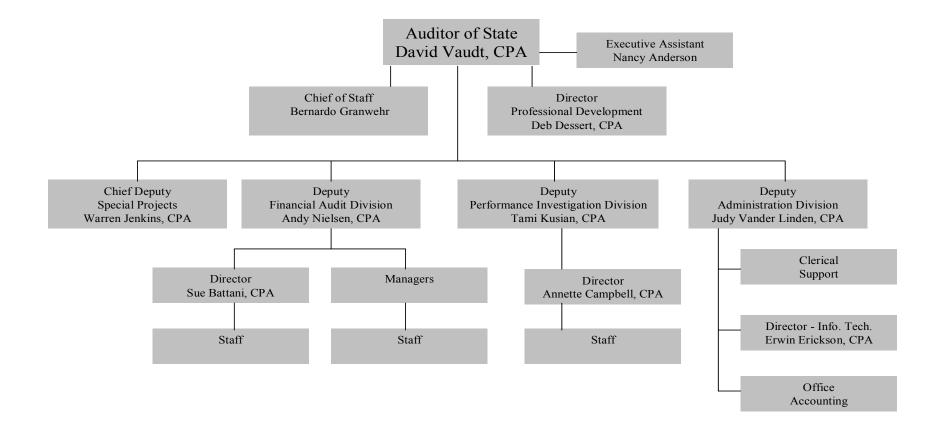
Performance Investigation Division ----- Deputy - Tami Kusian, CPA
