Underfunded & Unfunded Mandates In The County Recorders' Offices

Underfunded Mandates

- **Iowa Department of Natural Resources**
 - Vehicle Licensing & Renewals
 - Groundwater Hazard Statements
- lowa Department of Revenue
 - o DOV Forms
- lowa Department of Public Health
 - Vital Records (Birth, Marriage, Death)

Marriage Application Processing



Marriage Application History

- July 1, 1997
 - Marriage Application Process switches from the Clerk of District Court's office to the Office of the County Recorder
- Marriage license processing fee was \$30
 - All of which was remitted to the State of Iowa
- County Recorder's take on more responsibility
 - Code of Iowa required County Recorder's to process marriage license requests for no additional fee to the user.
- Process subsidized by County Taxpayers
 - County Property Taxpayers across the State of Iowa started to subsidize a user-based service.



Marriage Application Fees Evolves

2005

IDPH raises certified copy fees to \$15 by Administrative Code

County Recorder Retains \$4 of certified copy charge

 The County Recorder retained \$4 of the cost of a certified copy to cover costs associated with processing.

Marriage Applications Fees change to \$35

Cost includes a certified copy of the marriage certificate

State retains all processing fee

Of the \$35 charged to the customer, \$31 is remitted to the State of Iowa. The County Recorder retains \$4 for the processing of the certified copy after the marriage certificate has been filed.



Marriage Application Fee Breakdown

Marriage Application Fee Prior to January 1, 2014

- \$20.00 State General Fund
- \$8.00 State Registrar/Vital Records
- \$3.00 State General Fund
- \$4.00 County Recorder (fee for certified copy)
- \$35.00 Total

Marriage Application Fee beginning January 1, 2014

- \$15.00 State General Fund
- \$13.00 State Registrar/Vital Records
- o \$3.00 State General Fund
- \$4.00 County Recorder (fee for certified copy)
- \$35.00 Total



Keep In Mind...

 That the application for a license to marry and the fee for such was originally a Clerk of District Court function, which is a state-funded office whose monies went into the state general fund. On July 1, 1997, vital records duties previously performed by the Clerks of District Court were transferred to the County Recorder's office, a county-funded office. The monies generated from processing the License to Marry, however, were never duly transferred to the County Recorder's office.

How These Costs Affect A County Floyd County, IA

- Marriage Applications processed from 2008 through 2013
 - o 1,512 marriage applications
 - Approximately 856 hours of work
 - Average wage of deputies over 5 year period in Floyd County per hour
 - \$20.30
 - Total cost (wages only) to the county for processing without compensation (34 minutes)
 - -\$17,376
- County Recorder's have been processing marriage applications for no additional fee for 15 years. That cost (wages only)over the entire state is at a conservative

-\$2,262,000.

How do we compare

Minnesota

- Marriage application fee \$115 without pre-marital classes
 - \$40 with pre-marital classes
 - State share \$75/\$15
 - o County share \$25
 - Certified Copy 1 included/\$9 for additional

Missouri

- Marriage application fee \$46
 - State share \$17
 - County share \$29
 - Certified Copy \$9
 (not included in application cost)
