

TEST CASE 1 – (Institutional)

PURPOSE:

1. The purpose of this test case is to verify that if a pay-to-provider id is not one of the special ids assigned to provider eligible for Medicaid reform then the input claim should get denied with exception code 653 – PROVIDER NOT IN IOWACARE NETWORK.

TEST CASE 2 (Institutional)

PURPOSE:

1. The purpose of this test case is to verify that if the claim type is not either an Inpatient claim or Outpatient claim, then the input claim should get denied with exception code **657 – SERVICE NOT COVERED BY IOWOCARE.**

TEST CASE 3 (Institutional)

PURPOSE:

1. The purpose of this test case is to verify that if a claim abides to all the rules of IOWACARE, then the claim does not get posted with any of the new edits. (Note, that it may still get posted with some existing edits).

After the test – the number of exceptions = 13 (652, 653 and a bunch of line level edits for procedure codes, etc.).

TEST CASE 6 (Medical)

PURPOSE:

1. **Line level edit** - The purpose of this test case is to verify that if the claim has wrong provider type on line level (the valid provider types on a medical claim are – Physician – 02 & 03 and Nurse practitioner – 50 only), then the input claim should get denied with exception code **655 – PROVIDER TYPE MUST BE PHYSICIAN, AMBULANCE, OR NURSE PRACTITIONER.**

This edit will not be posted for Ambulance claims.
