# IOWA COLLEGE STUDENT AID COMMISSION Resource Material Education Appropriations Subcommittee January 26, 2006

The following pages include background information and recommendations for the appropriation for the fiscal year beginning July 1, 2006 and ending June 30, 2007.

The Governor's recommendations are highlighted in this report. Recommendations created by Commission staff and endorsed by the Commission are included to help explain the process that resulted in the Governor's recommendation. The Governor's recommendations were created using the Seller/Buyer model and ranks within the Student Achievement drilling platform. The Commission input into that process included extensive feedback from Iowa college and university financial aid professionals, members of the Commission, and other stakeholders in Iowa higher education student financial aid. Meetings were held with representatives of the community colleges, independent colleges and universities, proprietary colleges and universities, Des Moines University and the National Guard. Input was received from Regent officials throughout the year, and was incorporated into the proposals. Table 1 presents a history of the appropriations since FY 2003 – 2004 and recommendations for FY 2006 - 2007.

## **Proposal Summary**

#### **Iowa Tuition Grant**

Provide 16,600 lowa students at lowa independent colleges and universities and proprietary colleges and universities with grants of up to the statutory maximum award of \$4,000. Iowa independent colleges and universities and proprietary institutions will match 79% of the appropriation from institutional funds.

#### **Vocational-Technical Tuition Grant**

The Governor's recommendation will provide Vocational-Technical Tuition Grants for 2,281 vocational-technical students at Iowa community colleges with awards of up to \$1,200. This is a status-quo recommendation. The Commission recommendation advocated assistance for 6,569 students by increasing the appropriation by \$1 million.

#### Iowa College Work-Study

The Governor proposed a status quo budget of \$140,000 to serve 220 students for FY 2006 - 2007. Commission staff proposed an increase in

the amount to \$300,000, and Commissioners endorsed an increase that would return the appropriation to \$2.75 million to serve 4,300 students provided that the appropriation does not supplant other education appropriations. All proposals encourage lowa colleges and universities to utilize work-study funds to reduce debt and provide practical experience.

#### Iowa Grants

Both the Governor and the Commission proposed a status quo budget that would maintain lowa Grant funds at the same level as in recent years. This will allow the grant to continue to utilize LEAP funds that may become available for lowa students.

#### National Guard Program

Both the Governor and the Commission proposed a status quo budget of \$3,800,000 to serve 1,200 members.

## Teacher Shortage Forgivable Loans

Both the Governor and the Commission proposed a status quo budget to maintain the appropriation at the FY 2005 – 2006 level. This will provide 95 forgivable loans to students at lowa colleges and universities with forgivable loans of up to \$3,000. Students accepting the awards agree to teach in areas of high need in lowa. Loans will be forgiven at a rate of 20% per year for each year that the graduate teaches in lowa. The program will be supplemented with \$981,169 in federal funds to provide forgivable loans for an additional 327 students.

#### Osteopathic Forgivable Loans

This program requires graduates of Des Moines University to practice medicine in Iowa communities. The Governor's proposal includes a state appropriation of \$50,000 and Des Moines University will match the amount with \$50,000 to provide \$2,500 in forgivable loans for up to 40 additional students. Eighty-nine students are receiving assistance from previous appropriations. Upon completion of residency programs, students receiving forgivable loans give quality health care to lowans.

## Physician Recruitment Program

This program attracts and retains qualified medical professionals to Iowa communities with populations of less than 10,000 residents. The Governor's proposal of \$346,451 will provide up to two students at Des Moines University with tuition scholarships and up to eight physicians with

loan repayment benefits. Iowa communities struggling to attract qualified medical professionals match the state's loan repayment benefits.

Internships for Iowans in Washington, DC.

This new program would provide 64 scholarships of \$1,200 for Iowa students studying in Washington, DC. During the 2004 – 2005 academic year, 64 Iowa students from six colleges and universities attended one-semester, college-credit internship programs coordinated by The Washington Center for Internships and Academic Seminars. Proposed funding would provide assistance not only to those studying at the Washington Center, but also to students associated with other not-for-profit internship providers.

#### Administration

The Governor's proposal for administration will support an FTE employment of 4.3. The requested amount increases the funding for administration of state appropriated programs.

Des Moines University





Chart 2
