IMCC Special Needs Unit (SNU)

Primary Functions

- 1. Provide acute and long-term housing for offenders with significant health care and/or ambulation challenges.
- 2. Provide specialized and general medical support to offenders who have:
 - a) Been discharged from hospital care
 - b) Who have long-term medical problems
 - c) A need for higher level of mental health care
- 3. Continue to provide the initial medical and mental health evaluation and treatment services to reception offenders
- 4. Facilitate medical appointments with the University of Iowa Hospitals and Clinics.
- 5. Increased programming and evaluation for offenders with mental health and behavioral challenges.
- 6. Provide relief to overcrowding in current reception and segregation units.

IMCC Special Needs Unit (SNU)

Medical Unit

- 1. Appointment Clinics on First Level
 - Relocate existing IMCC Health Services Clinic
- 2. Infirmary on Second Level
 - Inpatient ward
 - Patients with limited ability for self-care
 - Need for Medical isolation
 - Managing Infectious Diseases
 - Continuous monitoring and care needs
 - √ Tube feeding
 - $\sqrt{O_2}$ Therapy
 - √ IV therapy
 - $\sqrt{}$ Intensive post operative recuperation
- 3. Short-Term Care Ambulatory Care (Second Level)
 - Able to conduct activities of daily living
 - Rehabilitative services
 - Frequent trips to UIHC (e.g., cancer treatment)
 - Post-operative care and monitoring that does not requiring inpatient
 - Intensive medical work-ups
 - Two rooms for females
- 4. Long-Term Care (Third Level)
 - Men age 55 or older needing assistance in activities of daily living
 - Requires lifting or assistance with transfer activities
 - Requires chronic monitoring due to disorientation or confusion
 - Patient with tube-feedings
 - Problems with incontinence
 - Requires assistance with food intake

IMCC Special Needs Unit (SNU)

Behavioral Unit

- 1. Appointments Holdover Unit on First Level
 - Both single and double cells
 - Facilitate hospital appointments
- 2. Secure Observation Area on First Level
 - Mental Health Acute Care
 - Mental Health Observation
 - Suicide and Self-Injury Protocol Observation
 - Administrative Segregation of Special Need Offenders
 - Disciplinary Detention for Special Need Offenders
- 3. Two two-tiered celled housing units on Second/Third Level
 - Reception units for special needs offenders
 - All single cells
 - Longer reception stays
 - √ Additional Assessment
 - √ Stabilize mental health conditions

IMCC Special Needs Unit (SNU)

Capacity (178 beds)

- 1. Infirmary 24 beds (4 double rooms, 12 single rooms, 4 isolation rooms)
- 2. Short-Term Ambulatory Care -30 beds (all double rooms)
- 3. Long-Term Care 32 beds (all 4-person rooms)
- 4. Transportation Holdover Housing Unit 24 beds (8 single and 8 double cells)
- 5. Secure Observation 20 beds (single cells)
- 6. Special Needs Reception Program Housing 48 beds (2 Units, 24-single cells each)
