Iowa Veterans Cemetery

- State-owned and operated
- United States Department of Veteran Affairs National Cemetery Administration rules and guidelines
- Located 10 miles west of Des Moines at I-80 exit 113 (Van Meter)
- 100 acres; 50 acres developed
- Planned for 81,000 interments in-ground full casket and cremated remains and columbaria walls
- Monday-Friday operations; four time slots available per day
- Open 365 days a year; sunrise to sunset
- Current staff of five two cemetery representatives; three grounds operators
- 2,298 Interments a/o Tuesday, 20 January 2015
