




#### **Recidivism Rate**

"Recidivism Rate" is defined as the percent of offenders released from prison or work release who returned to prison within three years. The releases tracked are paroles, discharges due to end of sentence and sex offender releases to special sentence supervision.

#### Recidivism Rate (Cont.)






## Recidivism Rate (Cont.)



While analysis is not available for every reporting year, available data shows the *type* of recidivism that appears to have declined is the return to prison due to new conviction. The rate of return to prison for technical reasons appears to have remained stable.

## Recidivism Rate (Cont.)



Over the past two recidivism reporting periods, there has been no statistically significant difference in recidivism rates between Non-Hispanic/White and Non-Hispanic/Black offenders.

#### ICON

- The Board will continue to utilize technology in order to increase accuracy and reduce costs
- As funds permit FY 2016 & FY 2017 will see continued ICON development
  - Victim Registration and Notification Module
  - Commutation & Clemency Module
  - Statistical/Dashboard Module

#### What the Future Holds

#### ICON (cont.)

- ICON can increase efficiencies if digitization occurs with existing paper case files
- The Board is exploring ways to complete this project in the most cost effective manner utilizing existing resources to the greatest extent possible
- Current assessment projects up to 15,000 files need digital migration
- Better understanding of needs by end of FY 2015
- If funds permit FY 2017 Capital Technology Reinvestment Fund request may be made
