- Board of Directors consisting of Public Safety Officials and members of the Private Sector
 - Charged with creating the National Public Safety Broadband Network
 - Dedicated to Public Safety users
 - 7 Billion allocated to construct
 - Funding from FCC spectrum auctions

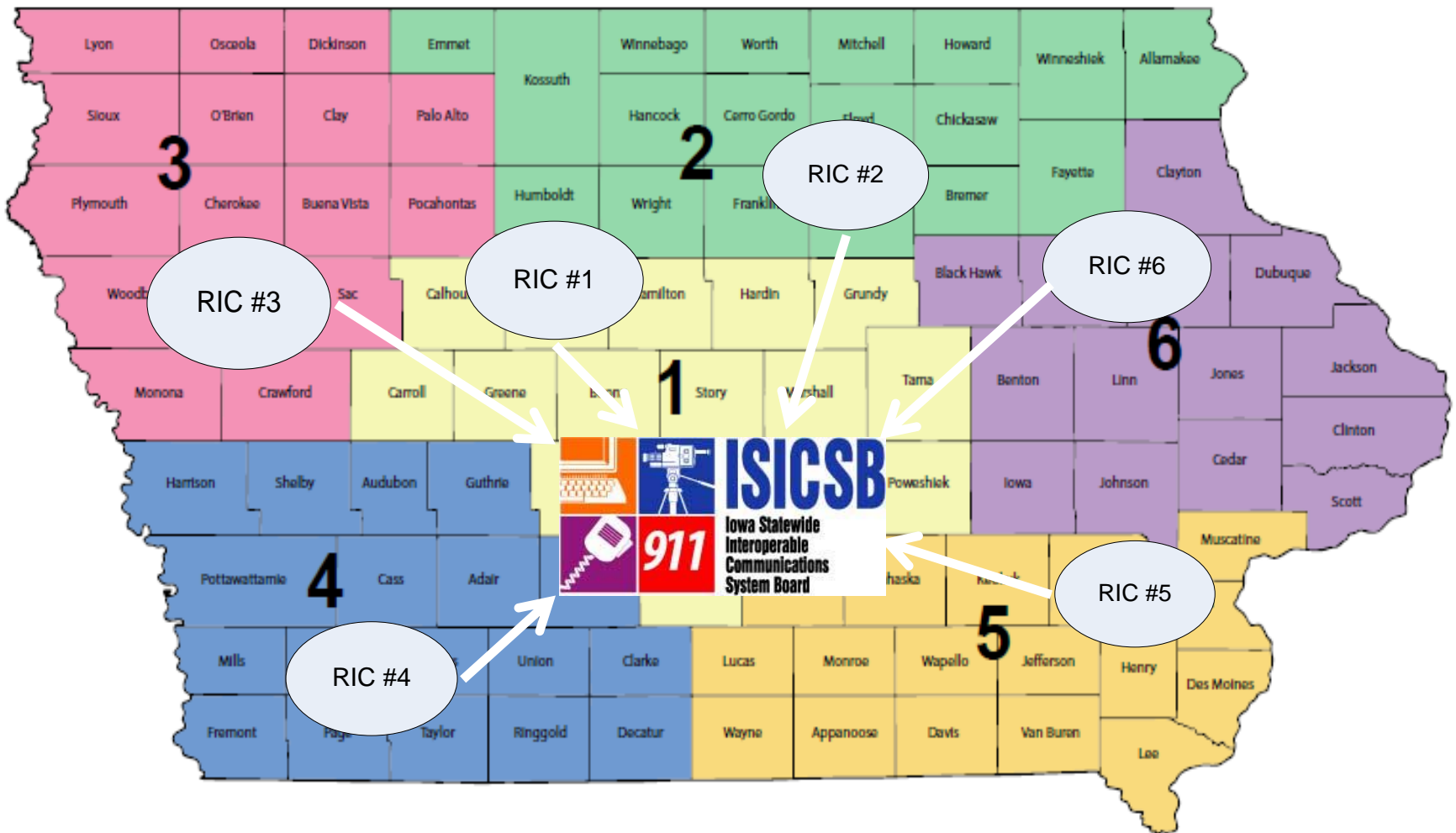

OPT in or OPT Out

- Each State must make a decision to OPT in or OPT out, by Law
- OPT in , FIRSTNET handles the RFP and builds the Network with input from the State
- OPT out , each state will build their own network, conforming to all the standards of FRISTNET
- Must have a plan in place in 120 days from decision to OPT OUT.



AS OF TODAY

- No decision has been made to opt in or opt in or opt out.
- Several more consultation meetings will be held in Iowa to help make that decision
- Infrastructure assessment is taking place now by the FIRSTNET Broadband Sub Committee
