Hamilton > Probate Records, Vol 1-5, 1892-1918

STATE OF IOWA, HAMILTON COUNTY, SS.

To all to whom these Presents shall come, Greeting:

Know Ye, that whereas Peter Berglund late of Hamilton County, Iowa, died intestate, on or about the 6th day of October A. D. 1874 having at the time of his decease, personal property in this State, which may be lost, destroyed, or diminished in value if speed care be not taken of the same; to the end, therefore, that said property may be collected and preserved, and administered upon as by law required, the District Court of Hamilton County does hereby appoint and commission Anna Berglund Administratrix of all and singular the goods, chattels, rights, credits, and effects which belonged to said decedent at the time of his decease, with full power and authority to secure and collect the said property and debts, wherever the same may be found in this State, and in general to do and perform all other acts which law or equity may require of her; by her.

In Testimony Whereof, I have hereunto set my hand and record the seal of said Court to be affixed, at Water City, this 22nd day of January A. D. 1892.


