7 "b. If a motor vehicle was registered as an
8 antique vehicle pursuant to section 321.115 prior to
9 January 1, 2009, and either the motor vehicle has been
10 titled in the same person's name since the vehicle was
11 new or the title to the vehicle was transferred prior
12 to January 1, 2009, the registration fee shall be
13 twenty-three dollars for a motor vehicle that is model
14 year 1970 through 1983 and sixteen dollars for a motor
15 vehicle that is model year 1969 or older."

16 3. Page 5, line 4, by striking the word "For" and
17 inserting the following:

18 "c. For".

19 4. Page 5, line 5, by striking the words "this
20 subsection" and inserting the following: "paragraph
21 "a" or "b"".

1 Amend LSB 6462JA as follows:

2 1. Page 1, by striking lines 13 through 29.

3 2. Page 2, lines 2 and 3, by striking the words
4 "business-trade trucks,".

5 3. Page 5, by striking lines 8 through 24.

6 4. Page 7, lines 2 and 3, by striking the words
7 and figure "required to be registered under section
8 321.109" and inserting the following: "with an
9 unladen weight of ten thousand pounds or less".

10 5. Page 7, by striking lines 11 through 30 and
11 inserting the following:

12 "a. For a combined gross weight of three tons or
13 less, sixty-five dollars; and a vehicle which is more
14 than ten model years old, fifty-five dollars; and a
15 vehicle which is more than thirteen model years old,
16 forty-five dollars; and a vehicle which is more than
17 fifteen years old, thirty-five dollars.

18 b. For a combined gross weight exceeding three
19 tons, the annual registration fee shall be as set
20 forth in the following schedule:
