

(Per 100,000):

Missouri: 530

South Dakota: 413

Indiana: 412

Illinois: 360

Kansas: 328


Iowa: 281

Patterns We're Seeing

Iowa's violent crime recidivism rate is on a slow but steady rise.

(Pictured)

Additionally, FBI data is indicating a rise in violent crime in rural areas while going down in metro-areas.

Question: How Does Corrections play
a role in creating a safer Iowa?

Short Answer: Reducing recidivism

If we had "BUSINESS AS USUAL..."

(constant recidivism rates)

Total Number of Recidivism for FY14-17: 1623

Average Cost per Day: \$92.16

Average Length of Stay: 507.7 days

Total Cost: \$75,939,573

(based on average statewide length of stay)

However: Reducing recidivism rates saves
money and prevents crime victims:

10% Recidivism reduction savings:


\$7,593,957

20% of Recidivism reduction savings:

\$15,187,915

2) Continued focus on criminal justice reforms that both ensure justice for victims but can also reduce the prison population...


3) and the support to maintain safety in the prisons/ community and also implement the data-driven tools/programs


FY2018 General Fund Appropriations

Total: \$377,701,155




FY2017 Judicial District Department Revenues




FY2017 Judicial District Department Expenditures




CBC Staff and Population




Community-Based Corrections: Supervision Ratios

Resources: Increasing Medical Costs


Prison Population Over Age 50

Recidivism Reduction Matters



Public safety:

Helps reduce recidivism, resulting in fewer victims of crime and stops the revolving door of the criminal justice system



Stronger families:

Promotes family reunification and pro-social relationships



Improved community well-being:

Improves economic outcomes and yields healthier communities.



Smarter use of taxpayer dollars:

Reduces costly reincarceration, which diverts public resources away from other public priorities, such as education and social services
