SCHOOL DIRECTOR DISTRICT REDISTRICTING

July 10, 1984

At the last meeting of the Iowa Legislative Counsel on June 12, 1984, there were 27 Iowa school districts which had not yet had their director redistricting plans approved by the Office of the Secretary of State. As of today's date there are 8 school districts which do not yet have their plans approved. A list of these school districts is attached.

Under section 275.23A, Code Supplement 1983, if a school district board fails to make the required changes in the drawing of its director districts, the Secretary of State shall "make or cause to be made the necessary changes as soon as possible, and shall assess any expenses incurred to the school district." Some potential expenses which could be assessed to a school district resulting from costs incurred by the Legislative Service Bureau in redistricting are:

1. Hourly rate of personnel who are redistricting.
2. Secretarial costs, paper, postage, etc.
3. Cost of map reproduction and in some cases cost of map acquisition.
4. If the school district contains a city which must be divided for which no block census data is available:
  - a. Mileage for traveling to the city.
  - b. Additional hourly rate of personnel who are performing housing unit counts.
  - c. Meal and possibly lodging reimbursement for traveling personnel.

The school district could also be charged with costs incurred by the Office of the Secretary of State.

REPORT OF THE STUDIES COMMITTEE

to the

LEGISLATIVE COUNCIL

July 10, 1984

The Studies Committee of the Legislative Council met at 10:30 a.m. in Committee Room 22 of the State House to review remaining requests for interim studies and memberships of the interim committees and submits the following report for the approval of the Legislative Council:

1. That a Supreme Court Rules Subcommittee be established. The Subcommittee shall consist of three members of the Senate and three members of the House and be authorized one meeting day.

2. That an Economic Development Study Committee be established and authorized to expend up to \$150,000 for employing a consultant. The Study Committee shall consist of six members of the Senate and six members of the House and seven citizen members including three business representatives, three labor representatives, and one agriculture representative. The Study Committee shall be authorized four meeting days.

3. That a Child Protection Study Committee be established consisting of five members of the Senate and five members of the House and be authorized three meeting days.

4. That a Health Care Cost Study Committee be established consisting of five members of the Senate and five members of the House and be authorized three meeting days.

5. That a Sinking Fund Study Committee be established consisting of five members of the Senate and five members of the House and be authorized two meeting days.

6. That the Legislative Council authorize the Speaker of the House after consultation with the House majority leader, the House minority leader, and the Senate majority and minority leaders to appoint the three members to the Drunk Driving Study Committee to comply with the statutory mandate.
