[HF 2459](#) Quirnbach COMMITTEE BILL -- A bill for an act relating to the individual income tax by creating a tax credit for reserve peace officers and by increasing the amount of the tax credit for volunteer fire fighter and volunteer emergency medical services personnel and including retroactive applicability provisions. (Formerly [HF 2076](#)) By Ways & Means. (Eligible: 04/24/2014.)
