2006 Session Time Table

JANUARY 9	First day of session. (Iowa Code Sec.2.1)
JANUARY 13 <i>(Friday of 1st week)</i>	Final day for individual Senator requests for bill drafts to the Legislative Services Agency (SR 27)
JANUARY 20 <i>(Friday of 2nd week)</i>	Final day for individual Representative requests for bill drafts to the Legislative Services Agency (HR 29)
MARCH 3* <i>(Friday of 8th week)</i>	Final date for House bills to be reported out of House committees and Senate bills out of Senate committees (JR 20)
MARCH 6-10 <i>(9th week)</i>	House considers only House bills and unfinished business and Senate considers only Senate bills and unfinished business. (JR 20)
MARCH 13-24 <i>(10th and 11th weeks)</i>	Debate not limited by rule.
MARCH 24* <i>(Friday of 11th week)</i>	Final date for Senate bills to be reported out of House committees and House bills out of Senate Committees. (JR 20)
MARCH 27-31 <i>(12th week)</i>	House considers only Senate bills and unfinished business and Senate considers only House bills and unfinished business. (JR 20)
APRIL 3 <i>(Beginning of the 13th week)</i>	House amendments need not be filed on the day preceding floor debate. (House Rule 31.8)
APRIL 3 <i>(Beginning of the 13th week)</i>	Only the following bills are eligible for consideration by JR 20 unless otherwise indicated: <ul style="list-style-type: none"> • Appropriations Bills • Government Oversight Bills • Ways and Means Bills • Legalizing Acts • Bills co-sponsored by Majority and Minority Leaders of one house • Companion bills sponsored by Senate and House Majority Leaders • Conference Committee Reports • Concurrent or simple resolutions • Bills passed by both houses in different forms • Bills on the Veto Calendar (JR 23) • Administrative Rules Review Committee Bills • Committee bills related to delayed Administrative Rules [Iowa Code Sec. 17A.8 (9)] • Joint Resolutions nullifying Administrative Rules • Unfinished business
APRIL 18	100th calendar day of the session (Per diem expenses end) [Iowa Code Sec.2.10(1)]

**The March 3 and March 24 committee deadlines do not apply to Appropriations Bills, Ways and Means Bills, Government Oversight Bills, bills co-sponsored by Majority and Minority Leaders of one house, companion bills sponsored by the Majority Leaders of both houses after consultation with the respective Minority Leaders, Conference Committee Reports, concurrent or simple resolutions, joint resolutions nullifying Administrative Rules, legalizing acts, Administrative Rules Review Committee Bills, and committee bills related to delayed Administrative Rules [Iowa Code Sec. 17A.8 (9)].*
