

# The Iowa Legislature General Assembly

## 2007 Session Time Table

<b>JANUARY 8</b>	First day of session. (Iowa Code Sec.2.1)
<b>FEBRUARY 16</b> <i>(Friday of 6th week)</i>	Final day for individual legislator requests for bill drafts to the Legislative Services Agency. (*SR 27 & HR 29)
<b>MARCH 9**</b> <i>(Friday of 9th week)</i>	Final date for House bills to be reported out of House committees and Senate bills out of Senate committees. (*JR 20)
<b>MARCH 19-23</b> <i>(11th week)</i>	House considers only House bills and unfinished business and Senate considers only Senate bills and unfinished business. (*JR 20)
<b>MARCH 26-April 6</b> <i>(12th and 13th weeks)</i>	Debate not limited by rule.
<b>April 6**</b> <i>(Friday of 13th week)</i>	Final date for Senate bills to be reported out of House committees and House bills out of Senate Committees. (*JR 20)
<b>April 9-13</b> <i>(14th week)</i>	House considers only Senate bills and unfinished business and Senate considers only House bills and unfinished business. (*JR 20)
<b>APRIL 16</b> <i>(Beginning of the 15th week)</i>	House amendments need not be filed on the day preceding floor debate. (House Rule 31.8)
<b>APRIL 16</b> <i>(Beginning of the 15th week)</i>	Only the following bills are eligible for consideration by *JR 20 unless otherwise indicated: <ul style="list-style-type: none"> <li>• Appropriations Bills</li> <li>• Government Oversight Bills</li> <li>• Ways and Means Bills</li> <li>• Legalizing Acts</li> <li>• Bills co-sponsored by Majority and Minority Leaders of one house</li> <li>• Companion bills sponsored by Senate and House Majority Leaders</li> <li>• Conference Committee Reports</li> <li>• Concurrent or simple resolutions</li> <li>• Bills passed by both houses in different forms</li> <li>• Bills on the Veto Calendar (*JR 23)</li> <li>• Administrative Rules Review Committee Bills</li> <li>• Committee bills related to delayed Administrative Rules [Iowa Code Sec. 17A.8 (9)]</li> <li>• Joint Resolutions nullifying Administrative Rules</li> <li>• Unfinished business</li> </ul>
<b>APRIL 27</b>	110th calendar day of the session (Per diem expenses end) [Iowa Code Sec.2.10(1)]

**\*\*The March 9 and April 6 committee deadlines do not apply to Appropriations Bills, Ways and Means Bills, Government Oversight Bills, bills co-sponsored by Majority and Minority Leaders of one house, companion bills sponsored by the Majority Leaders of both houses after consultation with the respective Minority Leaders, Conference Committee Reports, concurrent or simple resolutions, joint resolutions nullifying Administrative Rules, legalizing acts, Administrative Rules Review Committee Bills, and committee bills related to delayed Administrative Rules [Iowa Code Sec. 17A.8 (9)].**


