Legislative Services Agency Fiscal Services Division

Nonpartisan agency of the General Assembly

Provide objective fiscal analysis to both chambers and both political parties on legislation and legislative proposals

- Assist General Assembly with developing a balanced budget .
- Analyze and monitor the status of appropriations bills through the legislative process.
- Primary staff for appropriations subcommittees.
- Provide information and analysis of State revenues and expenditures. (Budget Analysis)
- Evaluate the fiscal impact of legislative proposals for State and local government. (Fiscal Notes)
- Review the operations of State government for efficiencies and determine if the programs work as intended.



Fiscal Services Division

Fiscal Services Publications:

- **Fiscal Report (Graybook)** Annual end-of-session fiscal report that includes analysis of legislation passed by the General Assembly.
- **Issue Review** In depth analysis of fiscal and budgetary issues.
- **Fiscal Topics** One- to two-page summaries reviewing selected State government issues or topics.
- **Factbook** Statistics on Iowa's government, economy, and population.
- **Fiscal Update** Fiscal Services newsletter
- Analysis of Department Budget Requests Summary analysis of department requests and general budget outlook for the next fiscal year.

Fiscal Services Publications (continued):

- Analysis of Governor's Budget Recommendations Overall analysis of the Governor's proposed budget
- Detailed Analysis of Governor's Budget Recommendations by Subcommittee (Blue Books) – Document for each subcommittee that provides more in depth analysis of the Governor's proposed budget.
- Notes on Bills and Amendments Provides fiscal analysis of each section of an appropriations bill.
- **Fiscal Notes** A nonpartisan analysis of estimated costs and/or changes in revenues of proposed legislation.
- **Special Requests** Fiscal staff can provide information and analysis of a specialized nature on request.



- State Board of Regents Economic Development




State General Fund FY 2011-Total \$5.3 Billion


Department of Cultural Affairs

The Department of Cultural Affairs collects, organizes, preserves, interprets, and disseminates Iowa's artistic, historical, and cultural resources. The Department consists of three divisions:

- State Historical Society of Iowa (SHSI Historical Division) Oversees State Historical Museum, State Archives and Records, State Historic Preservation Office, State Historical Libraries, Iowa History Publications, Historic Resource Grants, Battle Flag Preservation Project, State Historic Sites, Civil War Sesquicentennial Committee, Archiving Former Governor's Papers, and Records Center Rent.
- Iowa Arts Council (Arts Division) Oversees arts grant programs and technical assistance, Art in State Buildings Program, Iowa Folklife Program.
- Administration Oversees Iowa Great Places, Iowa Cultural Trust, Community Cultural Grants and other grant programs, Cultural and Entertainment Districts, U.S.S. Iowa committee, and DCA operations.


Department of Economic Development

The mission of the Department is to continually develop the economic wellbeing and quality of life of lowans.

The Divisions within the Department include:

- Administrative Services Division includes the following activities: Administration, Director's Office, Communications, Economic Development Board, Department of Administrative Services Billings, Iowa Commission On Volunteerism, and Technological Services.
- Business Development Division includes the following activities: Advertising & Promotion, Export Assistance, Film Office, German Office, Innovation & Commercialization, International Trade, Japan Office, National Marketing, Partner State Program, Regulatory Assistance, and the Iowa Careers Consortium Project.
- Community & Rural Development: Community Development Block Grant State Administration, Community Assistance, Mainstreet, Community Development Fund, Community Development Administration, Tourism Operations, and Tourism Marketing.






Specific General Fund appropriations are made for the following:

- The Iowa Commission for Volunteer Services promotes and expands mentoring throughout the State by working with the Iowa Mentoring Partnership and other local groups.
- The Historical Preservation Challenge Grants provide matching funds for the United States Department of Housing and Urban Development's Main Street Challenge Grants for historic building preservation.
- The World Food Prize is an international award recognizing the achievements of individuals that have advanced human development by improving the quality, quantity, or availability of food in the world. The Prize recognizes contributions in any field involved in the world food supply -- food and agriculture science and technology, manufacturing, marketing, nutrition, economics, poverty alleviation, political leadership, and the social sciences.

Iowa Workforce Development

The Divisions within the Iowa Workforce Development include:

- The Division of Administrative Services provides administrative support functions for the Department, including employee services, building/premises management, office services, financial reporting, and accounting.
- The Division of Labor Services is responsible for the enforcement of programs designed to protect the safety, health and economic security of all lowans. The programs are also designed to protect employees from dangers in the workplace and protect employees' rights to be paid wages. The Division protects lowa's children from dangers in the workplace. The Division's activities include; Occupational Safety and Health Administration (OSHA); contractor registration; asbestos permits and inspections, amusement ride inspections, boiler and elevator permitting and licensing.



Iowa Workforce Development

- Workers' Compensation provides adjudication, compliance, and education, pertaining to Workers' Compensation claims.
- The Labor Market and Workforce Information Division provides labor market information. The Division collects, analyzes and prepares economic statistics and information that describes labor areas in terms of economic trends, industries, occupations, wages and workers.
- The Unemployment Insurance Services Division provides services to businesses, workers, and the citizens of Iowa, by collecting unemployment insurance taxes, maintaining the Iowa Unemployment Compensation Trust Fund, and making payments to eligible jobless workers.
- The Division of Workforce Center Administration is responsible for the delivery of various State and federally funded employment and training services. Services are delivered through 15 regional one-stop centers and 55 local offices.




Department of Workforce Development

Specific General Fund appropriations are made for the following:

- The Security Employee Training Program provides security training for people that work in specified jobs at specified establishments.
- Offender Reentry Program provides integration services for prison inmates prior to their release.
- The Employee Misclassification Program investigates employers that misclassify workers as independent contractors when these workers should legally be classified as employees.


