The Senate met in regular session at 8:38 a.m., President Lamberti presiding.

Prayer was offered by the Reverend Steve Peters, pastor of the Trinity United Methodist Church in Fort Dodge, Iowa. He was the guest of Senator Beall.

The Journal of Tuesday, March 22, 2005, was approved.

The Senate stood at ease at 9:16 a.m. until the fall of the gavel for the purpose of party caucuses.
