Des Moines, Iowa, Wednesday, April 13, 2005

The Senate met in regular session at 8:32 a.m., President Kibbie presiding.

Prayer was offered by the Reverend Roger Kurtenbach, pastor of the Epworth United Methodist Church in Fort Dodge, Iowa. He was the guest of Senator Beall.

The Journal of Tuesday, April 12, 2005, was approved.

The Senate stood at ease at 8:35 a.m. until the fall of the gavel for the purpose of party caucuses.

The Senate resumed session at 11:08 a.m., President Kibbie presiding.

## CONSIDERATION OF RESOLUTION (Regular Calendar)

Senator Iverson asked and received unanimous consent to take up for consideration [Senate Resolution 24](#).

### [Senate Resolution 24](#)

On motion of Senator Wieck, [Senate Resolution 24](#), a resolution honoring the Morningside College Women's Basketball Team on their national championship, with report of committee recommending passage, was taken up for consideration.

Senator Wieck moved the adoption of [Senate Resolution 24](#), which motion prevailed by a voice vote.

### SPECIAL GUESTS

Senator Wieck introduced the Morningside College Women's Basketball Team and their coach Jamie Sale. They were accompanied by Morningside College President John Reynders and Athletic Director Jerry Schmutte. Mr. Reynders, Mr. Sale, and basketball player Beth Watson all addressed the Senate with brief remarks.

The Senate rose and expressed its welcome.

On motion of Senator Iverson, the Senate recessed at 11:15 a.m. until 2:00 p.m.

### AFTERNOON SESSION

The Senate reconvened at 2:04 p.m., President Kibbie presiding.

### HOUSE MESSAGES RECEIVED AND CONSIDERED

MR. PRESIDENT: I am directed to inform your honorable body that the House has on April 13, 2005, **adopted** the following resolutions in which the concurrence of the House was asked:

**Senate Joint Resolution 6**, a joint resolution authorizing the temporary use and consumption of wine in the State Capitol in conjunction with the awards ceremony of the World Food Prize Foundation.

**Senate Joint Resolution 7**, a joint resolution authorizing the temporary use and consumption of wine and beer in the State Capitol in conjunction with the 2005 National Governors Association Annual Meeting.

ALSO: That the House has on April 13, 2005, **passed** the following bills in which the concurrence of the House was asked:

**Senate File 339**, a bill for an act relating to regional transit districts.

**Senate File 346**, a bill for an act appropriating federal funds made available from federal block grants and other federal grants, allocating portions of federal block grants, and providing procedures if federal funds are more or less than anticipated or if federal block grants are more or less than anticipated.

ALSO: That the House has on April 13, 2005, **amended and passed** the following bills in which the concurrence of the Senate is asked:

**Senate File 325**, a bill for an act relating to the procedures and duties of the judicial branch, including sending notices and reports, and providing an effective date. (**S-3114**)

**Senate File 340**, a bill for an act relating to motor vehicle registration and driver licensing services provided by county treasurers and providing for the collection of certain fees, fines, and penalties. (**S-3115**)

**Senate File 365**, a bill for an act relating to the application deadline for certification of enterprise zones. (**S-3117**)

**House File 537**, a bill for an act relating to the investment of public funds by the treasurer of state, state agencies, and political subdivisions including the investment of public funds not covered by federal deposit insurance in certificates of deposit.

Read first time and **attached to companion Senate File 266**.

**House File 832**, a bill for an act relating to coupling Iowa's tax laws with the federal Internal Revenue Code and including an applicability date provision.

Read first time and referred to committee on **Ways and Means**.

[House File 834](#), a bill for an act relating to persons commercially cleaning toilet units and private sewage disposal facilities by providing regulations, fees, and civil penalties, and making appropriations.

Read first time and referred to committee on **Ways and Means**.

[House File 835](#), a bill for an act relating to the port authorities including providing for the establishment, control, and dissolution of port authorities and providing for certain powers, limitations, and requirements including issuing revenue bonds and pledge orders, charging fees, entering into contracts and agreements, employing persons and peace officers, and providing for the use of revenues and exemption from property taxes.

Read first time and referred to committee on **Ways and Means**.

[House File 839](#), a bill for an act providing for the establishment of a technology governance board within the department of administrative services, and making an appropriation.

Read first time and referred to committee on **Appropriations**.

Senator Putney offered amendment [S-3085](#), filed by him on April 5, 2005, to page 1 and to the title page of the bill.

Senator Connolly raised the point of order that amendment [S-3085](#) was not germane to the bill.
