- $\underline{S.F.}$  283 Relating to the department of public safety by updating references, changing the names of divisions in the department, and changing practices and procedures.
- $\underline{\text{S.F. }320}$  Requiring performance of a criminal history check of applicants for real estate broker and salesperson licenses.
  - S.F. 339 Relating to regional transit districts.
- $\underline{S.F.~346}$  Appropriating federal funds made available from federal block grants and other federal grants, allocating portions of federal block grants, and providing procedures if federal funds are more or less than anticipated or if federal block grants are more or less than anticipated.
- $\underline{\text{S.F. }379}$  Relating to the Iowa probate code, the Iowa trust code, and certain other trusts.
