Senate File 342, a bill for an act relating to appropriation matters by making and increasing appropriations for the fiscal year beginning July 1, 2004, and providing effective and applicability date provisions. (S-3321)

ALSO: That the House has on May 11, 2005, **amended** the Senate amendment, **concurred** in the Senate amendment as amended, and **passed** the following bills in which the concurrence of the Senate is asked:

House File 761, a bill for an act relating to children's programs by colocating early childhood programs available through the community empowerment initiative and requiring the department of human services to develop and implement a voluntary child care quality rating system. (S-3320)

<u>House File 808</u>, a bill for an act relating to and making appropriations involving state government, including provisions affecting agriculture and natural resources. (S-3319)
