The Senate met in regular session at 8:39 a.m., President Lamberti presiding.

Prayer was offered by the Honorable Dave Mulder, member of the Senate from Sioux County, Sioux Center, Iowa.

The Journal of Monday, May 16, 2005, was approved.

HOUSE MESSAGE RECEIVED

The following message was received from the Chief Clerk of the House:

MR. PRESIDENT: I am directed to inform your honorable body that the House has on May 16, 2005, appointed the conference committee to [House File 816](#), a bill for an act relating to the funding of, the operation of, and appropriation of moneys to the college student aid commission, the department for the blind, the department of cultural affairs, the department of education, and the state board of regents, and the conference committee members on the part of the House are: The Representative from O'Brien, Representative Chambers, Chair; the Representative from Butler, Representative Dix; the Representative from Johnson, Representative Mascher; the Representative from Polk, Representative Oldson; the Representative from Madison, Representative Tymeson.

The Senate stood at ease at 8:42 a.m. until the fall of the gavel for the purpose of party caucuses.

The Senate resumed session at 10:55 a.m., President Lamberti presiding.
