The Senate met in regular session at 9:14 a.m., President Lamberti presiding.

Prayer was offered by Alyce Elmitt, secretary to President of the Senate Jeff Lamberti.

MOTIONS TO RECONSIDER WITHDRAWN

House File 811

Senator Gronstal withdrew the motion to reconsider **House File 811**, a bill for an act relating to and making appropriations to the justice system and providing an effective date, filed by him on May 4, 2005, found on page 1137 of the Senate Journal, and previously deferred on May 17, 2005.

House File 825

Senator Gronstal withdrew the motion to reconsider **House File 825**, a bill for an act relating to and making appropriations to the department of human services, the department of elder affairs, the Iowa department of public health, the commission of veterans affairs and the Iowa veterans home, and the department of inspections and appeals, providing for fee increases, and including other related provisions and appropriations, and providing effective dates, filed by him on May 4, 2005, found on page 1137 of the Senate Journal, and previously deferred on May 17, 2005.

House File 882

Senator Gronstal withdrew the motion to reconsider **House File 882**, a bill for an act making, reducing, and transferring appropriations, providing for fees, and providing for properly related matters and including effective and retroactive applicability date provisions, filed by him on May 6, 2005, found on page 1177 of the Senate Journal, and previously deferred on May 17, 2005.

Also, Senator Angelo, on behalf of Senator Iverson, withdrew the motion to reconsider <u>House File 882</u>, filed by Senator Iverson on May 9, 2005, found on page 1180 of the Senate Journal.

With the withdrawal of the motions to reconsider <u>House File 882</u>, the Chair ruled amendment <u>S-3322</u>, filed by Senator Connolly on May 16, 2005, to page 48 and to the title page of the bill, out of order.
