# JOURNAL OF THE SENATE

Senate Chamber Des Moines, Iowa, Tuesday, April 9, 2024

The Senate met in regular session at 9:03 a.m., President Sinclair presiding.

Prayer was offered by the Honorable Jason Schultz, member of the Senate from Crawford County.

HOUSE MESSAGES RECEIVED AND CONSIDERED

The following messages were received from the Chief Clerk of the House:

MADAM PRESIDENT: I am directed to inform your honorable body that the House has on April 8, 2024, **passed** the following bill in which the concurrence of the House was asked:

**Senate File 2054**, a bill for an act eliminating requirements providing for the payment of an outstanding tax liability by dissolved business entities as a condition to reinstatement.

ALSO: That the House has on April 8, 2024, **concurred** in the Senate amendment **and passed** the following bill in which the concurrence of the House was asked:
