

CHAPTER 15

APPROPRIATION FOR REVISION OF SCHOOL STUDY COURSES

S. F. 359

AN ACT to provide an emergency appropriation to complete the preparation of an elementary course of study for the rural and graded schools of the State of Iowa, and a course of study for normal training high schools, in order to complete the work already begun by the Department of Public Instruction.

WHEREAS, the department of public instruction of the state of Iowa has entered upon and is prosecuting the revision and rewriting of courses of study to be used in the elementary, graded, and normal training high schools of the state of Iowa; and

WHEREAS, the appropriation for the biennium ending June 30, 1941, is insufficient to complete the work of revision, rewriting, and distribution of said courses of study and have said courses ready for distribution to the schools on or near September 1, 1941; and

WHEREAS, the department of public instruction finds that in order to complete this work of revision and rewriting courses of study for the use of the schools of the state of Iowa and to reimburse the department of public instruction for funds already expended on this project it is necessary to secure an additional appropriation in the sum of five thousand dollars (\$5,000.00) to be made immediately available for said purposes; therefore,

Be It Enacted by the General Assembly of the State of Iowa:

1 SECTION 1. There is hereby appropriated from the general funds
2 of the state not otherwise appropriated a sum of five thousand dollars
3 (\$5,000.00) to be made immediately available to the department of
4 public instruction for the completion of the revision, rewriting, and
5 distribution of courses of study for the elementary, graded, and normal
6 training high schools now in preparation and to reimburse the depart-
7 ment of public instruction for funds already expended on this project.
8 The state comptroller is authorized to issue state warrants for this
9 purpose upon requisition of the superintendent of public instruction.

1 SEC. 2. This act being deemed of immediate importance shall be in
2 full force and effect from and after its passage and publication in the
3 Cherokee Daily Times, a newspaper published at Cherokee, Iowa, and
4 the Tipton Advertiser, a newspaper published at Tipton, Iowa.

CHAPTER 16

STATE OFFICE BUILDING APPROPRIATION

S. F. 419

AN ACT to provide for the erecting and equipping of an office building on the State Capitol grounds; to provide for the appointment of a legislative advisory committee and authorize the executive council and legislative advisory committee to designate the location of said building; to authorize the executive council and legislative

advisory committee to employ an architect or architects to prepare plans and specifications for said office building; and to enter into a contract or contracts for the erection and equipping of said office building; and to provide for an appropriation therefor.

Be It Enacted by the General Assembly of the State of Iowa:

1 SECTION 1. That for the purpose of the erection and equipping of
2 an office building on the state capitol grounds, the executive council
3 and legislative advisory committee are authorized and empowered to
4 employ an architect or architects for the purpose of preparing plans
5 and specifications for said office building, and to approve said plans
6 with such changes and alterations as the executive council and legis-
7 lative advisory committee may deem proper and appropriate. The
8 executive council and legislative advisory committee shall be authorized
9 and empowered to enter into a contract or contracts for the erection
10 and equipping of said building, provided however, that that total cost of
11 erecting and equipping said office building including any architect
12 fees shall not exceed one million six hundred and fifty thousand
13 (1,650,000.00) dollars; all contracts for the erection and equipping
14 of said office building shall be let in accordance with Chapter eighteen
15 (18), of Code of Iowa, 1939, and all laws amendatory thereto.

1 SEC. 2. Said office building shall be located on the state capitol
2 grounds, the executive council and the legislative advisory committee
3 are authorized and empowered to designate the exact location of said
4 building within said capitol grounds.

1 SEC. 3. During the biennium beginning July 1, 1941, there is here-
2 by appropriated out of the general fund for the first year of said bien-
3 nium the sum of eight hundred twenty-five thousand (825,000.00)
4 dollars and out of the general fund for the second (2) year of said
5 biennium the sum of eight hundred twenty-five thousand (825,000.00)
6 dollars, which shall be expended for the erection and equipping of said
7 office building as herein provided.

1 SEC. 4. There shall be created a legislative advisory committee
2 consisting of three members of the senate and three members of the
3 house to be appointed by the respective presiding officer of the senate
4 and house, for the purpose of carrying out the legislative intent of this
5 act.

6 The term of the legislative advisory committee shall terminate upon
7 the convening of the 50th General Assembly. Any vacancy occurring
8 on the legislative advisory committee shall be filled by the presiding
9 officer of the House in the event the vacancy occurs in the membership
10 of said committee from the House, and by the Lieutenant Governor in
11 the event the vacancy occurs in the membership of said committee from
12 the Senate.

13 In carrying out the provisions of this act the executive council and
14 the legislative advisory committee shall meet jointly at such places
15 as may be determined by the executive council and in determining all
16 matters coming before said meetings it shall require a majority vote of
17 the members of the joint committee of the executive council and of the
18 legislative advisory committee. The legislative advisory committee

19 shall meet and organize on the second Monday in May, 1941, and at
 20 the same time and immediately following its organization, meet with
 21 the executive council in order that the committee and council may
 22 advise on carrying out the provisions of this act.

1 SEC. 5. Each member of the legislative advisory committee shall be
 2 entitled to such hotel and traveling expenses incurred in the discharge
 3 of their duties and such allowance for time spent in the discharge of
 4 their duties as may be allowed by the 50th General Assembly.

1 SEC. 6. In the event that the executive council and the legislative
 2 advisory committee shall in their discretion determine that it would
 3 not be to the best interests of the state to proceed with the erection of
 4 said building during the biennium beginning July 1, 1941, the moneys
 5 appropriated by this act shall be segregated in a fund to be known as
 6 the State Office Building Fund to be used for the purposes provided
 7 in this act at such future time as the executive council and the legisla-
 8 tive advisory committee may determine, and said fund, if not previously
 9 expended for the purposes provided herein, shall not revert to the
 10 general fund until such time as the General Assembly may by act or
 11 joint resolution provide therefor, anything in any other act or law to
 12 the contrary notwithstanding.

1 SEC. 7. If any section, subsection, clause, sentence or phrase of this
 2 act is for any reason held to be unconstitutional and invalid, such
 3 decision shall not affect the validity of the remaining portions of this
 4 act. The legislature hereby declares that it would have passed this
 5 act and each section, subsection, clause, sentence or phrase hereof,
 6 irrespective of whether any one or more of the sections, subsections,
 7 clauses, sentences, or phrases be declared unconstitutional.

1 SEC. 8. Insofar as section three (3), Chapter fourteen (14) of the
 2 Acts of the Thirty-fifth General Assembly is in conflict with this act,
 3 the same is hereby repealed.

1 SEC. 9. This act being deemed of immediate importance shall be-
 2 come effective upon publication in the Centerville Daily Iowegian, a
 3 newspaper published at Centerville, Iowa, and in the Clinton Herald,
 4 a newspaper published at Clinton, Iowa.

CHAPTER 17

STATE UNIVERSITY LIBRARY BUILDING APPROPRIATION

S. F. 526

AN ACT to appropriate from the general fund of the state, for the biennium beginning July 1, 1941, and ending June 30, 1943, to the board of education for improvement and equipment at the State University of Iowa, Iowa City.
