

1 SEC. 4. There is hereby appropriated out of the general fund of
2 the State of Iowa, to F. J. Pine of Columbus Junction, Iowa, the sum
3 of one hundred ten dollars (\$110.00) in full settlement of all claims
4 which he may have against the State of Iowa on account of services
5 rendered as member of Iowa Industrial and Defense Commission.

1 SEC. 5. There is hereby appropriated out of the general fund of
2 the State of Iowa, to Sanford Zeigler, Jr., of Fairfield, Iowa, the sum
3 of one hundred thirty dollars (\$130.00) in full settlement of all
4 claims which he may have against the State of Iowa on account of
5 services rendered as member of Iowa Industrial and Defense Com-
6 mission.

1 SEC. 6. There is hereby appropriated out of the general fund of the
2 State of Iowa, to B. C. Whitehill, Marshalltown, Iowa, the sum of one
3 hundred thirty dollars (\$130.00), in full settlement of all claims which
4 he may have against the State of Iowa on account of services rendered
5 as member of the Iowa Industrial and Defense Commission.

1 SEC. 7. There is hereby appropriated out of the general fund of
