1 SEC. 5. The officers of the association shall serve without com-2 pensation, but shall receive their necessary expenses while engaged 3 in the business of the association.

ICE CREAM STANDARD OF MILK FAT

H. F. 216

AN ACT to amend the law as it appears in paragraphs 33, 34, and 35, section three thousand fifty-eight (3058) of the code of Iowa, 1939, relating to the standard by weight of milk fat in ice cream.

Be It Enacted by the General Assembly of the State of Iowa:

1 SECTION 1. That the law as it appears in Paragraph 33, Section 2 Three Thousand Fifty Eight (3058), Code of Iowa, 1939, be and the 3 same is hereby amended by adding thereto at the close of said Para-4 graph 33 the following: "Provided that from and after the taking 5 effect of this act and until April 30, 1945, ice cream shall contain not 6 less than eight per cent by weight of milk fat."

1 SEC. 2. That the law as it appears in Paragraph 34, Section 3058, 2 Code of Iowa, 1939, be and the same is hereby amended by adding 3 thereto at the close of said Paragraph 34 the following:

4 "Provided that from and after the taking effect of this act and until
5 April 30, 1945, fruit ice cream shall contain not less than six per cent
6 by weight of milk fat."

1 SEC 3. That the law as it appears in Paragraph 35, Section 3058, 2 Code of Iowa, 1939, be and the same is hereby amended by adding 3 thereto at the close of said Paragraph 35 the following:

4 "Provided that from and after the taking effect of this act and 5 until April 30, 1945, nut ice cream shall contain not less than seven 6 per cent by weight of milk fat."

CHAPTER 120

DAIRY INDUSTRY ACT

S. F. 258

AN ACT relating to the dairy industry, and to conserve and promote the prosperity and welfare of the Iowa dairy industry and of the state of Iowa by promoting the increased use and consumption of dairy products, whether processed or unprocessed, by providing for a research, educational, publicity, advertising and sales promotion campaign; to levy and impose an excise tax on butter fat produced in this state during the period from June 1 to June 15, inclusive, of each year and to provide for the collection thereof by the producer or dealer, for the purpose of creating a fund with which to conduct such research, educational, advertising publicity, and sales promotion campaign; to create the Iowa Dairy Industry Commission, and to vest the administration of this act in such commission; to provide for the particular duties and authority of said commission hereunder; and to provide penalties for violation of this act.

Be It Enacted by the General Assembly of the State of Iowa:

SECTION 1. As used in this Act:

2 (a) The term "commission" shall mean the Iowa Dairy Industry 3 Commission;

4 (b) The term "person" shall mean individuals, corporations, part-5 nerships, trusts, associations, cooperatives, and any and all other 6 business units.

7 (c) The term "producer" shall mean and include every person who 8 produces milk or cream from cows or goats and thereafter sells the 9 same as milk, cream or other dairy products.

10 (d) The term "dealer" shall mean and include any person who
11 buys, sells, manufactures, processes or ships dairy products, or who
12 acts as sales or purchasing agent, broker or factor of dairy products.

1 SEC. 2. There is hereby created an "Iowa Dairy Industry Com-2 mission" to be thus known and designated.

This commission shall be composed of the Secretary of Agriculture of Iowa, the head of the Dairy Husbandry Department of Iowa State College, the head of the Dairy Industry Department of Iowa State College, and in addition thereto nine (9) members appointed by the Executive Committee of the Iowa State Dairy Association as immediately hereinafter provided.
