

1 SEC. 11. Section five thousand thirteen and twenty-two hun-  
 2 dredths (5013.22), Code, 1939, is hereby amended by adding the  
 3 following sentence thereto: ", and provided further that any chauff-  
 4 feur's license issued on or after December 1 shall be valid for the  
 5 month of December in addition to the year following."

1 SEC. 12. Section five thousand fourteen and two hundredths  
 2 (5014.02), Code, 1939, is hereby amended by striking from line  
 3 three (3) the words "and any chauffeur's" and from line four (4)  
 4 the word "badge".

1 SEC. 13. Section five thousand fourteen and seven hundredths  
 2 (5014.07), Code, 1939, is hereby amended by inserting after the  
 3 word "state" in line three (3) the following: "or any city traffic  
 4 ordinances, other than parking regulations,". Said section is further  
 5 amended by striking all of the last sentence thereof.

1 SEC. 14. Section five thousand fourteen and twelve hundredths  
 2 (5014.12), Code, 1939, is hereby amended by striking from line two  
 3 (2) thereof the word "and" and inserting in lieu thereof following  
 4 the word "year" the following: ", except that a license suspended  
 5 because of incompetency to drive a motor vehicle shall be suspended  
 6 until the department receives satisfactory evidence that the former  
 7 holder thereof is competent to operate a motor vehicle and a refusal  
 8 to reinstate shall constitute a denial of license within the provisions  
 9 of section 5014.15;". Said section is further amended by inserting  
 10 after the word "license" and before the word "shall" in line three  
 11 (3) thereof the words "the department".

1 SEC. 15. Section five thousand fourteen and thirteen hundredths  
 2 (5014.13), Code, 1939, is hereby amended by striking from lines  
 3 two (2), three (3), and four (4) thereof the words "and the badge  
 4 of any chauffeur whose license is suspended or revoked shall" and  
 5 by striking from line seven (7) thereof the words "and any chauff-  
 6 feur's badge".

1 SEC. 16. Section one (1), chapter one hundred seventy-three  
 2 (173), Acts of the Forty-ninth General Assembly, is hereby amended  
 3 by striking from line six (6) thereof the following: "sixteen (16)",  
 4 and by inserting in lieu thereof the following: "fifteen (15)".

## CHAPTER 159

### CHAUFFEUR'S LICENSES

H. F. 477

AN ACT to amend chapter two hundred fifty-one and one-tenth (251.1), code, 1939, to provide for issuance by the county sheriff of a limited period chauffeur's license and to permit issuance by the department of a chauffeur's license to a person seventeen years of age.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 SECTION 1. When a department uniformed examiner is not avail-  
 2 able, the county sheriff may in his discretion accept from a person  
 3 holding a valid operator's license of this state or a valid chauffeur's

4 license of another state, application to the department for a  
 5 chauffeur's license accompanied by the regular fee therefor, and is  
 6 hereby authorized to issue a license to operate a motor vehicle as a  
 7 chauffeur, using forms provided by the department, to expire fifteen  
 8 days from issuance. The entire fee and application shall be turned  
 9 over to the department examiner on or before the date of expiration  
 10 of such license and if the applicant does not appear within the  
 11 calendar year for examination the license fee shall be considered an  
 12 earned fee, but if upon examination the application is denied, the fee  
 13 shall be returned to applicant by the department. No such license  
 14 shall be issued to any person who has within the same calendar year  
 15 been issued a license as herein provided or to any person previously  
 16 denied any license by the department.

1 SEC. 2. Notwithstanding the provisions of subsection two (2) of  
 2 section five thousand thirteen and four hundredths (5013.04), Code,  
 3 1939, the department is hereby authorized to issue to a person  
 4 seventeen years of age a license to operate a motor vehicle as a  
 5 chauffeur, upon application showing the information and signatures  
 6 required in section five thousand thirteen and ten hundredths  
 7 (5013.10), Code, 1939.

1 SEC. 3. This act being deemed of immediate importance shall be  
 2 in full force and effect from and after its passage and publication  
 3 in *The Oxford Mirror*, a newspaper published at Oxford Junction,  
 4 Iowa, and in the *Brooklyn Chronicle*, a newspaper published at  
 5 Brooklyn, Iowa.

## CHAPTER 160

### MOTOR VEHICLES

#### S. F. 218

AN ACT to amend chapter two hundred fifty-one and one-tenth (251.1), code, 1939, and to amend section five thousand thirteen and sixteen hundredths (5013.16), in said chapter, code, 1939; to repeal section five thousand thirteen and twenty-one hundredths (5013.21), in said chapter, code, 1939, and enact a substitute therefor relating to fees for licenses for operation of motor vehicles, extending the expiration date of such licenses and providing for issuance of licenses without examination.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 SECTION 1. Section five thousand thirteen and sixteen hundredths  
 2 (5013.16), Code, 1939, is hereby amended by striking the words "fifty  
 3 cents" in line two (2) thereof and inserting in lieu thereof the words  
 4 "seventy-five cents, except that fee for an operator's license issued to  
 5 expire July 5, 1943, shall be fifty cents and that fee for an operator's  
 6 license issued to expire subsequent to July 5, 1946, shall be fifty cents".
