

**CHAPTER 216**  
**ANNUAL COUNTY TAX LEVIES**

S. F. 168

AN ACT to amend section seven thousand one hundred seventy-one (7171), code, 1939, relative to annual levies.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 SECTION 1. Section seven thousand one hundred seventy-one  
2 (7171), Code, 1939, is hereby amended by striking all of said section  
3 following the word "revenue," in line nine thereof and inserting in  
4 lieu thereof the following: "not to exceed three mills on a dollar in  
5 counties having an assessed valuation of less than sixteen million  
6 dollars (\$16,000,000.00), not to exceed two and one-half mills on a  
7 dollar in counties having an assessed valuation of sixteen million  
8 dollars (\$16,000,000.00) or more and less than twenty-six million  
9 dollars (\$26,000,000.00), not to exceed two mills on a dollar in counties  
10 having an assessed valuation of twenty-six million dollars (\$26,000,-  
11 000.00) or more and less than thirty-two million dollars (\$32,000,-  
12 000.00), and not to exceed one and one-half mills on a dollar in counties  
13 having an assessed valuation of thirty-two million dollars (\$32,000,-  
14 000.00) or more."

15 In all counties having a population of thirty-five thousand (35,000),  
16 or more, and not more than forty thousand (40,000), and having an  
17 ordnance plant located therein owned by the United States govern-  
18 ment, the board of supervisors may, with the approval of the state  
19 comptroller, levy not to exceed two mills on a dollar under the provi-  
20 sions of this section.

**CHAPTER 217**  
**COURT EXPENSE FUND**

AN ACT to amend section seven thousand one hundred seventy-two (7172), code, 1939, relating to expenditures from the court expense fund, and legalizing expenditures heretofore made.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 SECTION 1. Section seven thousand one hundred seventy-two (7172),  
2 Code, 1939, is amended by striking from line two (2) the following:  
3 ", by reason of extraordinary or unusual litigation", and by striking  
4 from line four (4) the following: "the same," and inserting in lieu  
5 thereof the following: "all expenses incident to the maintenance and  
6 operation of the courts,".

1 SEC. 2. All expenditures heretofore made from the court expense  
2 fund in the necessary maintenance and operation of the courts, are  
3 hereby declared legal and valid.

1 SEC. 3. All laws or parts of laws in conflict herewith are hereby  
2 repealed.
