

CHAPTER 247

REGISTRATION OF TRADEMARKS, LABELS, AND ADVERTISEMENTS

H. F. 247

AN ACT to amend chapter four hundred thirty (430), code, 1939, relating to the registration of trademarks, labels and advertisements, providing for a limitation of the registration, and for the renewal of registrations, and fees therefor, and for renewal of registrations heretofore made.

Be It Enacted by the General Assembly of the State of Iowa:

1 SECTION 1. Chapter four hundred thirty (430), Code, 1939, is
2 amended by adding thereto the following as a separate section fol-
3 lowing section nine thousand eight hundred seventy (9870).

4 "The registration provided for in sections nine thousand eight hun-
5 dred sixty-seven (9867) to nine thousand eight hundred seventy
6 (9870) inclusive shall expire twenty years from the date thereof as
7 shown on the certificate of registration provided for in section nine
8 thousand eight hundred sixty-eight (9868), and may be renewed at
9 any time within three months before or after the date of termination
10 by filing an application for renewal in the office of the secretary of
11 state and the payment of the fees provided for in section nine thou-
12 sand eight hundred sixty-eight (9868), provided that during the
13 period within which a registration may be renewed the registrant
14 shall have the exclusive right of registration of such label, trademark,
15 or form of advertisement. Upon renewal of a registration, a certificate
16 thereof shall be issued as in an original registration."

1 SEC. 2. Any label, trademark, or form of advertisement registered
2 under chapter four hundred thirty (430), Code, 1939, prior to October
3 5, 1923, shall expire and terminate on April 5, 1944, unless within
4 six months prior to April 5, 1944, the registration of same has been
5 renewed by filing an application for renewal thereof and the payment
6 of the fees provided for in chapter four hundred thirty (430). Upon
7 renewal, a certificate thereof shall be issued as in the case of an
8 original registration.

CHAPTER 248

RELEASE AND SATISFACTION OF CHATTEL MORTGAGES AND CONDITIONAL SALES CONTRACTS

H. F. 285

AN ACT to amend section ten thousand twenty-eight (10028), code, 1939, relating to release and satisfaction of mortgages and conditional sales contracts.

Be It Enacted by the General Assembly of the State of Iowa:

1 SECTION 1. Section ten thousand twenty-eight (10028), Code,
2 1939, is amended:

3 1. By inserting in line one (1) after the word "mortgage" the
4 following: ", conditional sales contract,".

- 5 2. By inserting in line five (5) after the word "mortgage" the
6 following: "or conditional sales contract".
7 3. By striking in lines five (5) and six (6) the following: "or
8 by the mortgagee or his authorized agent", and insert in lieu thereof,
9 the following: "or by the mortgagee, vendor, or their authorized
10 agents".
11 4. By inserting the words "or conditional sales contract" imme-
12 diately before the words "on the index book" in line seven (7).

CHAPTER 249

SECONDHAND WATCHES

S. F. 75

AN ACT to amend chapter two hundred eighty-five (285), acts of the Forty-ninth (49th) General Assembly, relating to secondhand watches.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 SECTION 1. Section two (2) of chapter two hundred eighty-five
2 (285), Acts of the Forty-ninth (49th) General Assembly, is amended
3 by inserting in line two (2) after the word, "same" the word "a".

CHAPTER 250

RECORDING OF BANKRUPTCY PETITIONS AND ORDERS

H. F. 168

AN ACT to amend sections ten thousand sixty-six (10066), ten thousand one hundred six (10106) and ten thousand one hundred eleven (10111), code, 1939, authorizing and requiring the recording of certified copies of petitions in bankruptcy and of orders approving trustees' bonds in bankruptcy; and to provide for the indexing thereof.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 SECTION 1. Section ten thousand sixty-six (10066), Code, 1939,
2 is hereby amended by inserting immediately after the words "real
3 estate" in line three (3) the following:
4 "including certified copies of petitions in bankruptcy with or
5 without the schedules appended, of decrees of adjudication in bank-
6 ruptcy, and of orders approving trustees' bonds in bankruptcy"

- 1 SEC. 2. Section ten thousand one hundred six (10106), Code,
2 1939, is hereby amended by inserting immediately after the word
3 "affidavits" in line four (4) the following:
4 "and certified copies of petitions in bankruptcy with or without the
5 schedules appended, of decrees of adjudication in bankruptcy, and
6 of orders approving trustees' bonds in bankruptcy"
