

## CHAPTER 269

LIMITATIONS OF ACTIONS FOR RECOVERY OF INTERESTS IN  
REAL ESTATE

S. F. 133

AN ACT to amend various sections of the code, 1939, relating to special limitations of actions in regard to the recovery of interests in real estate.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 SECTION 1. Section eleven thousand twenty-one (11021), Code,  
2 1939, is amended by striking from line seven (7) the words and fig-  
3 ures, "January 1, 1890" and inserting in lieu thereof the following,  
4 "January 1, 1930".

5 Further amend said section by striking from the last line the words  
6 and figures, "March 1, 1914" and insert in lieu thereof the following,  
7 "March 1, 1944".

1 SEC. 2. Section eleven thousand twenty-two (11022), Code, 1939,  
2 is amended as follows:

3 1. Strike from line three (3) the figures "1905" and insert in lieu  
4 thereof the figures, "1930";

5 2. Strike from lines ten (10) and eleven (11) the words, "the  
6 taking effect of this act" and insert in lieu thereof the following, "July  
7 4, 1943";

8 3. Strike from lines twenty (20) and twenty-one (21) the words,  
9 "the taking effect of this act" and insert in lieu thereof the following,  
10 "July 4, 1943".

11 4. Strike the last sentence in said section.

1 SEC. 3. Section eleven thousand twenty-four (11024), Code, 1939,  
2 is amended by striking from lines two (2) and eleven (11) the figures  
3 "1920" and inserting in each instance the figures, "1930" in lieu  
4 thereof.

5 Further amend said section by striking from line fifteen (15) the  
6 figures "1931" and inserting the figures "1943" in lieu thereof.

1 SEC. 4. Section eleven thousand twenty-seven (11027), Code, 1939,  
2 is amended by striking from line eighteen (18) the word and figures  
3 "July 4, 1919" and inserting in lieu thereof the following, "prior to  
4 July 4, 1943".

1 SEC. 5. Section eleven thousand twenty-nine (11029), Code, 1939,  
2 is amended by striking from line ten (10) the figures, "1905" and in-  
3 serting the figures "1930" in lieu thereof.

4 Further amend said section by striking from lines eleven (11) and  
5 fourteen (14) the figures, "1917" and inserting the figures "1945" in  
6 lieu thereof.

7 Further amend said section by striking from line twenty-four (24)  
8 the figures, "1915" and inserting the figures "1943" in lieu thereof.

1 SEC. 6. Section eleven thousand twenty-three (11023), Code,  
2 1939, is hereby repealed and the following enacted in lieu thereof:

3 "Section 11022, Code, 1939, as amended by this act, shall not affect  
4 pending litigation, nor shall it operate to revive rights or claims pre-

5 viously barred, nor permit an action to be brought or maintained upon  
6 any claim or cause of action which is barred by any statute which is  
7 in force prior to July 4, 1943."

## CHAPTER 270

### PUBLICATION OF COURT PROCEEDINGS

#### H. F. 225

AN ACT to amend chapter four hundred ninety (490), relating to publication of notice of filing petition in commencement of actions in district court, and section eleven thousand four hundred thirty-nine (11439), relating to assignment of cases, motions and demurrers, and to amend section eleven thousand four hundred forty-one (11441), relating to court calendar, and to amend section ten thousand eight hundred thirty-seven (10837), relating to filing fees, and to amend section eleven thousand three hundred forty-nine (11349), all of the code, 1939, relating to proof of publication, and to provide for publication in a daily newspaper of general circulation of the title of district court cases and all related matters, and the compensation therefor, in all counties having a population of one hundred sixty thousand or over.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 SECTION 1. Chapter four hundred ninety (490), Code, 1939, is  
2 amended by adding thereto as a new section the following: "When  
3 the petition provided for in section eleven thousand one hundred  
4 eleven (11111), Code, 1939, is filed with the clerk of the district court  
5 in a county of one hundred sixty thousand population or over, the  
6 names of the parties plaintiff and defendant in such action, the des-  
7 cription of the real estate involved, if any, except for quieting title,  
8 partition, and suits involving tax assessments, and the names of the  
9 attorneys for the plaintiff, and the docket number assigned to such  
10 case, may be published once in a daily newspaper having a general  
11 circulation in said county; such paper to be designated by a majority  
12 of the judges of the district court. Provided, that whenever there-  
13 after such case is assigned for trial or any other pleadings are filed  
14 therein, or court action taken with reference thereto, except general  
15 orders of court for continuations, the title of such case and kind of  
16 pleading shall be published, and if it is in an assignment for trial it  
17 shall be carried in printed assignment from day to day until final  
18 disposition."

1 SEC. 2. Section eleven thousand four hundred thirty-nine (11439),  
2 Code, 1939, is amended by adding after the word "necessary" in line  
3 eight (8) the following: ", which assignments as made from time to  
4 time, whether of cases for trial or of hearings on motions or demur-  
5 rers, in counties of a hundred sixty thousand or over, shall be published  
6 and included in the related matters to be published as provided in  
7 section one (1) of this act"

1 SEC. 3. Section eleven thousand four hundred forty-one (11441),  
2 Code, 1939, is amended by adding thereto the following: ", but the  
3 publication of the assignments as provided in section one (1) of this  
4 act shall be in lieu of the publishing of a court calendar except that at
