1 SEC. 3. Nothing in this Act shall be deemed or construed to affect  
2 pending litigation, if any, involving said Corporation.

1 SEC. 4. This Act being deemed of immediate importance shall  
2 take effect and be in force from and after its publication in Plain Talk,  
3 a newspaper published in Des Moines, Iowa, and in The Des Moines  
4 Daily Record, a newspaper published in Des Moines, Iowa, without  
5 cost to the State.

## CHAPTER 289

### SAUL-EDMUND FURNITURE COMPANY

#### S. F. 253

AN ACT to legalize the corporate acts and proceedings in connection with the renewal of the corporate existence and the adoption of the amended and renewed articles of incorporation of the Saul-Edmund Furniture Company and to provide for the renewal of the charter of said company.

WHEREAS, the period of the corporate existence of the Saul-Edmund Furniture Company, a corporation organized under the laws of the state of Iowa, with its principal place of business in the city of Ottumwa, Iowa, expired on the 19th day of April, 1942, and through inadvertence the same was not renewed within the period prescribed by statute, and,

WHEREAS, the Saul-Edmund Furniture Company has continued thereafter to conduct its business and affairs as a corporation, and,

WHEREAS, on the 15th day of July, 1942, at special meeting of the stockholders called for the purpose of extending and renewing the said corporation for a period of twenty years from April 19, 1942, and adopting the amended and renewed articles of incorporation, and,

WHEREAS, the Saul-Edmund Furniture Company has filed the said amended and renewed articles of incorporation together with a certificate of renewal of the said corporation with the secretary of state of the state of Iowa, and has paid the proper renewal fees and recording fees, and has in all other particulars complied with the provisions of the statutes relating to renewals of corporations, now, therefore;

*Be It Enacted by the General Assembly of the State of Iowa:*

1 SECTION 1. All proceedings had with respect to the renewal of the  
2 corporate existence of the Saul-Edmund Furniture Company, a cor-  
3 poration with its principal place of business in Ottumwa, Iowa, and

4 all corporate acts of said corporation, its officers and stockholders,  
 5 since the expiration of the corporate existence of said corporation on  
 6 the 19th day of April, 1942, are hereby legalized and shall have the  
 7 same force and effect as though the said proceedings had been adopted  
 8 pursuant to law and within the period prescribed by the statute, and  
 9 shall be held and considered as a renewal and extension of the period  
 10 of the corporate existence of said corporation, which expired on April  
 11 19, 1942, and all corporate acts and proceedings of said corporation,  
 12 including the proceedings in connection with the renewal and exten-  
 13 sion of said corporation and the adoption of the amended and re-  
 14 newed articles of incorporation, are hereby declared to be valid and  
 15 legal.

1 SEC. 2. The secretary of state is hereby authorized and directed  
 2 to acknowledge and file and record the certificate of renewal of said  
 3 corporation previously delivered to him by said corporation, and to  
 4 issue a certificate of renewal to the Saul-Edmund Furniture Company,  
 5 said renewal to extend the corporate existence of said corporation for  
 6 a period of twenty years from April 19, 1942, which certificate of  
 7 renewal shall have the same force and effect as though issued upon  
 8 proper and timely application by said corporation.

1 SEC. 3 Nothing in this act shall be deemed or construed to affect  
 2 pending litigation, if any, involving said corporation.

1 SEC. 4. This act, being deemed of immediate importance, shall be  
 2 in full force and effect from and after its passage and publication in  
 3 the Ottumwa Daily Courier, a newspaper published at Ottumwa, Iowa,  
 4 and the Eddyville Tribune, a newspaper published at Eddyville, Iowa,  
 5 without expense to the State of Iowa.

## CHAPTER 290

### BUTLER COUNTY

#### H. F. 294

AN ACT to make permanent a certain temporary transfer of funds of Butler county,  
 Iowa, made by authority of the state comptroller.

WHEREAS, on application of the board of supervisors of Butler County,  
 Iowa, the state comptroller, on the tenth day of December, 1937, author-  
 ized and approved a temporary transfer of ten thousand dollars from the  
 bovine tuberculosis eradication fund of said county to the county fund of  
 said county; and

WHEREAS, by order of the board of supervisors of said county there has  
 been returned to said bovine tuberculosis eradication fund from the coun-  
 ty fund the sum of fifteen hundred dollars on February 3, 1942, and the  
 sum of five hundred dollars on June 30, 1942; and
