 9 Upon the making of said report to the Governor, the commission shall  
 10 stand discharged of its duties hereunder.

1 SEC. 4. There is hereby appropriated from the General Fund of  
 2 the State the sum of five thousand dollars to defray all expenses of  
 3 carrying out this Joint Resolution. Payments shall be made by  
 4 warrants drawn by the Comptroller upon certification by the Chairman  
 5 of the Commission.

1 SEC. 5. This Joint Resolution being deemed of immediate impor-  
 2 tance shall be in full force and effect from and after its publication in  
 3 the Ida County Pioneer Record, a newspaper published at Ida Grove,  
 4 Iowa, and in the Tipton Conservative, a newspaper published at  
 5 Tipton, Iowa.

### APPROPRIATION FOR GENERAL ASSEMBLY OFFICERS AND EMPLOYEES

A JOINT RESOLUTION fixing the compensation of officers and employees of the Fif-  
 tieth General Assembly.

*Be It Resolved by the General Assembly of the State of Iowa:*

1 SECTION 1. Pursuant to the provisions of section nineteen (19)  
 2 of the Code, 1939, it is provided that the daily compensation of all  
 3 officers and employees of the Fiftieth General Assembly be as follows,  
 4 to be paid in accordance with the rules of the Senate and House:

3 authorized to pay compensation to persons acting as temporary  
4 officers or employees, prior to the premanent\* organization of their  
5 respective houses, in the positions set forth in section one (1) and at  
6 the same scale of compensation as set forth therein.

1     SEC. 3. This act being deemed of immediate importance shall be  
2 in force and effect from and after its publication in the Daily Iowegian  
3 and Citizen, a newspaper published at Centerville, Iowa, and The  
4 Red Oak Express, a newspaper published at Red Oak, Iowa.
