

## CHAPTER 152

## MENTAL HEALTH TERMINOLOGY

H. F. 701

AN ACT relating to mental health terminology in the Code.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 SECTION 1. Section two hundred eighteen point four (218.4), Code  
2 1958, is hereby amended as follows:
