

CHAPTER 353

SALARIES IN MUNICIPAL COURTS

H. F. 451

AN ACT relating to the salaries of judges, clerks and bailiffs of municipal courts.

Be It Enacted by the General Assembly of the State of Iowa:

1 SECTION 1. Section six hundred two point forty-nine (602.49),
2 Code 1958, is hereby amended by striking all of lines one (1) through
3 thirty-three (33) and inserting in lieu thereof the following:

4 "The annual salary of each municipal judge shall be eight thousand
5 dollars (\$8,000.00). Upon the designation of any judge or judges of
6 the municipal court to act as judge or judges of the juvenile court,
7 the annual salary of such municipal court judge or judges so acting
8 shall be increased in the sum of five hundred dollars (\$500.00).

9 "Each clerk shall receive an annual salary of four thousand two
10 hundred dollars (\$4,200.00) in cities of less than thirty thousand
11 (30,000) inhabitants; five thousand dollars (\$5,000.00) in cities of
12 thirty thousand (30,000) and less than seventy thousand (70,000)
13 inhabitants; five thousand eight hundred dollars (\$5,800.00) in cities
14 of seventy thousand (70,000) and less than one hundred fifty thousand
15 (150,000) inhabitants; seven thousand dollars (\$7,000.00) in cities
16 of one hundred fifty thousand (150,000) or more inhabitants. The
17 salary of any clerk of a municipal court whose judge or judges act as
18 judge of the juvenile court shall be increased in the sum of two hun-
19 dred dollars (\$200.00) annually.

20 "Each bailiff shall receive an annual salary of four thousand dollars
21 (\$4,000.00) in cities of less than thirty thousand (30,000) inhabi-
22 tants; four thousand seven hundred dollars (\$4,700.00) in cities of
23 thirty thousand (30,000) and less than seventy thousand (70,000)
24 inhabitants; five thousand five hundred dollars (\$5,500.00) in cities
25 of seventy thousand (70,000) and less than one hundred fifty thou-
26 sand (150,000) inhabitants; six thousand eight hundred dollars
27 (\$6,800.00) in cities of one hundred fifty thousand (150,000) or more
28 inhabitants."

1 SEC. 2. The provisions of this Act shall become effective as of
2 January 1, 1960.

CHAPTER 354

POLK COUNTY DISTRICT JUDGES

AN ACT to amend section six hundred four point eight (604.8), Code 1958, pertaining to the number of district judges in Polk County.

Be It Enacted by the General Assembly of the State of Iowa:

1 SECTION 1. Section six hundred four point eight (604.8), Code
2 1958, is hereby amended by striking the word "seven" in line thirty-
3 three (33) and adding in lieu thereof the word "eight (8)".
