1 An Act making appropriations for certain health-related programs.
2 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. CHILD HEALTH SPECIALITY CLINICS. There is
2 appropriated from the general fund of the state to the Iowa
3 department of public health for the fiscal year beginning July
4 1, 2006, and ending June 30, 2007, the following amount, or so
5 much thereof as is necessary, to be used for the purpose
6 designated:

7 For increasing the funding for mobile and regional child
8 health specialty clinics in order for the clinics to expand
9 clinical operations:

10 \$ 439,000

11 Sec. 2. PACE COORDINATOR -- WESTERN IOWA. There is
12 appropriated from the general fund of the state to the
13 department of human services for the fiscal year beginning
14 July 1, 2006, and ending June 30, 2007, the following amount,
15 or so much thereof as is necessary, to be used for the purpose
16 designated:

17 For funding of a county-based coordinator position for the
18 program of all-inclusive care for the elderly (PACE) as
19 defined in section 249H.3:

20 \$ 62,000

21 The county-based coordinator shall assist the statewide
22 PACE program coordinator by working with PACE services in a
23 county with a population of more than 100,000 located on the
24 western border of the state. If possible, the department
25 shall implement the position in a manner that draws matching
26 federal medical assistance program funding. The department
27 may implement the position by allocating funding to a local
28 agency serving elder Iowans in order to coordinate local PACE
29 activities and services.

30 Sec. 3. STATE POISON CONTROL CENTER. There is
31 appropriated from the healthy Iowans tobacco trust created in
32 section 12.65 to the Iowa department of public health for the
33 fiscal year beginning July 1, 2006, and ending June 30, 2007,
34 the following amount, or so much thereof as is necessary, to
35 be used for the purpose designated:

1 For the state poison control center:
2 \$ 600,000

3 EXPLANATION

4 This bill makes appropriations for certain health-related
5 programs for the fiscal year beginning July 1, 2006.

6 An appropriation is made from the general fund of the state
7 to the Iowa department of public health to be used for mobile
8 and child health specialty clinics for expansion of clinical
9 services.

10 An appropriation is made from the general fund of the state
11 to the department of human services to be used for a county-
12 based coordinator for the federally defined program of all-
13 inclusive care for the elderly (PACE). The county-based
14 coordinator is required to work with PACE services in a county
15 of more than 100,000 population located on the western border
16 of the state.

17 An appropriation is made from the healthy Iowans tobacco
18 trust to the Iowa department of public health to be used for
19 the state poison control center.
