Procedural Business

Representative Jones convened the regular, statutory meeting of the Administrative Rules Review Committee (ARRC) at 9:04 a.m. on Friday, February 8, 2019, in Room 116, State Capitol, Des Moines, Iowa. The minutes of the January 8, 2019, meeting were approved. The next meeting was scheduled for Friday, March 8, 2019, at 9:00 a.m. Mr. Jack Ewing, Administrative Code Editor, provided a rule tracking update. The ARRC voted unanimously in favor, by voice vote, of nominating Representative Jones as Chairperson of the ARRC. The ARRC voted unanimously in favor, by voice vote, of nominating Senator Brown as Vice-Chairperson of the ARRC. Representative Jones encouraged agencies to follow the six-month law and implement rules within six months following the effective date of the implementing legislation. Additionally, Representative Jones encouraged agencies to contact floor managers of bills when implementing legislation by promulgating rules. Mr. Ewing presented the ARRC rules of procedure and explained that the committee staff information was out of date. The ARRC voted to adopt the ARRC rules of procedure with changes to the committee staff information. The meeting was adjourned at 11:37 a.m.

Fiscal Overview

INSURANCE DIVISION

ARC 4242C (NOIA), Short-Term Limited-Duration Health Insurance Policies, Proposed Amendment to Rule 35.23 and Proposed Adoption of Rules 36.4(17), 36.6(11), and 36.7(13)

Committee members inquired whether short-term plans that used to exist, which allowed consumers liberal ability to choose what they wanted, will continue to exist or whether such plans will now cease to exist under such rulemaking. Mr. Ommen stated that there would be some adjustment to very short-term plans, but such plans essentially will function as such plans always have functioned. Mr. Ommen stated that for plans longer than 180 days there will be a requirement for coverage for an annual check-up. Additional restrictions for longer plans that take the role of traditional major medical plans are being put in place, stated Mr. Ommen.

Committee members inquired whether a renewable plan requires a person to go without coverage for one day. Mr. Ommen stated that there is currently litigation on this issue; however, the rulemaking addresses the issue by providing that if a company advertises a plan as renewable, then the company must guarantee it as renewable. The person would not need to go one day without coverage, stated Mr. Ommen. Mr. Ommen stated this might be used by a person seeking the coverage as a bridge from retirement to Medicare.

Ms. Paula Dierenfeld, a member of the public, spoke on behalf of the Federation of Iowa Insurers, stating that Mr. Ommen spoke to the Federation and the companies composing the Federation and expressed support of the rulemaking.

No action taken on ARC 4242C.

ADMINISTRATIVE SERVICES DEPARTMENT

ARC 4244C (AF), Update of Human Resources Policies and Procedures, Amendments to Rules 68.1, 68.2(2), and 68.6

Committee members inquired whether the department intends that the mandatory training will be attended by statewide elected officials. Ms. Phipps stated that the department will encourage it; indicating that some statewide elected officials are covered by merit rules. Committee members inquired about the examples of sexual harassment and expressed concern that example number 3 was so narrow that it would imply that other situations, which the committee members deemed unacceptable, were acceptable. Ms. Phipps responded that the rulemaking initially omitted the examples, but examples were later added upon request, and the examples came from Iowa Code section 19B.12. Ms. Phipps also stated that actions may be found to violate the employment policy, which do not fit neatly within the examples. Additionally, Ms. Phipps stated that even if an action does not meet the legal standard of sexual harassment as a matter of law it may violate the employment policy. Committee members commented that perhaps a bill request is needed if committee members have a problem with the examples. Committee members inquired about why the rule states that the director of the department shall do the investigation unless otherwise directed by the Governor, but there is no standard as to why another person shall do this investigation or who shall do this investigation. Committee members inquired as to the circumstances that would lead to this scenario. Ms. Phipps stated this would occur if there was an allegation against her or a high-ranking person in the department. Committee members stated that the committee would prefer that the reason of a conflict of interest was stated in the rule in order to avoid the exercise of political favoritism by the Governor. Committee members inquired about the documentation of attendance at sexual harassment training by state employees. Ms. Phipps stated that documentation occurs and that she would make that available. No action taken on ARC 4244C.

Committee members said the department should be forewarned that people were investigating whether the department misappropriated funds for rules that have not been completed. Committee members stated that committee members understood the department had done this before; that the department had been shifting money around to circumvent rules.

Committee members inquired why the annual audits population threshold was changed from 700 to 2,000, and the time frame of audit once every four years was stricken and replaced by "as otherwise provided by law." Mr. McCormally responded that the amendment was proposed to be consistent with Iowa Code section 11.6. Mr. McCormally explained that cities with a population less than 2,000 or a budget less than \$2 million are subject to a periodic audit and are audited in effect once every eight years.

In response to questions from committee members, Mr. Dvorak explained the process the commission uses to designate usage of waters, which includes electrofishing, flow and depth measurements, and possibly interviews with residents of the area. A report on the water based on the data is then published for input from the public and affected facilities. He also explained that the repercussions of a facility discharging into an area designated as a recreation area include disinfection to meet E. coli standards and that this rulemaking implements a statutory permitting process. No action taken on ARC 4227C.

PUBLIC HEALTH DEPARTMENT

ARC 4240C (NOIA), Vaporizable Forms of Medical Cannabidiol, Proposed Amendment to Rule 154.14 In response to questions from committee members, Ms. Dixon explained that the department was given authority to establish allowable forms of medical cannabidiol in prior legislation and that the allowable forms are listed in the rulemaking. No action taken on ARC 4240C.

PHARMACY BOARD

In response to a question from committee members, Ms. Mears explained that language governing activities of pharmacist interns not carried out for the purpose of the internship is necessary because a pharmacist intern might be engaging activities as a pharmacy technician rather than as a pharmacy intern.

Committee members asked why the board used the term "prescribe" in the rulemaking when the underlying statute uses the term "order" instead. Ms. Mears explained that the term "order," as used in the bill, has a different meaning in a retail setting than in a hospital setting, but functionally the terms are the same. In response to another question, she explained that the protocols referenced in the rulemaking are not yet available on the board's internet site because they are still being developed.

Committee members, Mr. Ewing, and Ms. Mears discussed a draft of double-barreled rulemaking prepared by the board and distributed to the committee by Mr. Ewing that would change instances of "prescribe" to "order." Ms. Mears explained that the board could approve the rulemaking at its March 13 meeting and file it soon thereafter.

70-Day Delay

A motion was made for a 70-day delay of ARC 4270C. Mr. Ewing explained the committee's delay powers, including lifting a delay at a later time. Mr. Casey Ficek made a public comment on behalf of the Iowa Pharmacy Association. He explained that a current law regarding vaccinations would sunset on July 1, 2019, and that pharmacists hope for a smooth transition to a new law on July 1, 2019. He expressed concern that a delay of the rulemaking close to the transition date might complicate the transition. The motion for a 70-day delay carried 9-0 on a record roll call vote.

Emergency Rulemaking Authorized

Mr. Ewing explained emergency rulemaking procedures, including the committee's power to authorize emergency rulemaking. Mr. Ewing also explained double-barreled rulemaking. A motion to authorize emergency rulemaking by the board in accordance with the draft provided to the committee carried 9-0 on a record roll call vote.

Additional Review at April ARRC Meeting

Committee members scheduled additional review of this matter for its April meeting. Mr. Ewing explained that the authorized emergency rulemaking would be scheduled by the board to go into effect on the date of the April meeting, at which time the committee could vote to lift the delay, resulting in the delayed rulemaking and the authorized emergency rulemaking going into effect on the same day.
